# 30/16 Minutes of the meeting held on 19 December 2016

Cllr Nawaz confirmed his attendance at this meeting and it was also confirmed that Cllr Sandhu had sent his apologies. Subject to the attendance being amended the minutes of the meeting held on 19 December 2016 were confirmed as an accurate record.

# 31/16 Policing Restructure and Working Process Update

Jim Allen, Chief Superintendent of the South Division Police attended the meeting to update the Board on the re-organisation of the Force and how the City would be policed.

It was confirmed that Derbyshire Police Force had been divided into two divisions, North and South, with the City of Derby being covered by the South Division. This Division was then further divided into 4/5 distinct areas. It was also acknowledged that the City had been underserved for a number of years, 50+ officers had been transferred from the North Division and a big recruitment exercise was being conducted.

Discussion was held on how the police response had historically operated and how they were trying to improve the response to emergency calls. The Emergency response base was now at Cotton Lane and 25 officers would be

operating on 5 hour shifts.

It was also confirmed that no change would be made to the structure of the Safer Neighbourhood Teams and further discussion was held on the work they would cover. It was also acknowledged that some SNT would need to share community buildings and work remotely as the Police Force cannot sustain all its current buildings. Discussion was also held on CID operation and work.

Jim Allen stated it was too early to say if the changes have been a success or not, but certainly felt that the police service was healthy and well motivated and the Constabulary was reviewing the changes and tweaking to improve services. All acknowledged the excellent working partnership between the Police Force and the Council.

Jim Allen answered all the questions posed to him by the Board, which covered response times, making complaints, visibility and mobile device usage.

Discussions were then held on money available, from the Police Force, for the three local authorities to bid for, to help with prevent projects.
