06/03 Topic Review Report of the Regeneration and Social Inclusions Overview and Scrutiny Commission – Social Inclusion and the Physical Environment

Councillor Blanksby presented the report on the Social Inclusion and the Physical Environment to the Commission advising them of the processes which resulted in the final report that would be submitted to Council Cabinet. Councillor Blanksby advised that the Topic Review resulted in 30 recommendations, 26 of which could be agreed under the current legislation, four of which required changes to the law. (These four were numbered 5, 11, 16 and 25). Councillor Gerrard asked for recommendation 14 to be amended from "...engaging the Derby Evening Telegraph..." to "...engaging the local media..." The Commission agreed to this amendment.

Community Tensions Reporting

The Commission considered a report of the Chief Executive detailing the Community Tensions reporting framework by which Derbyshire Constabulary, D Division, Derby City Council, Derby Crime and Disorder Partnership – CDRP - and Derby Youth Offending Service Anti Social Behaviour team would work together to aim to prevent and provide an early response to Community Tensions in the city. Sharon Squires, Director Community Safety Partnership presented the report.

Sharon stated that this was a good example of joint working. Upon notification of a potential conflict, the Police would perform a risk assessment, liaising with Anti Social Behaviour team. The Police would inform all partner agencies of this conflict and a level of risk would be established. Levels of risk go from six (insignificant) to one (high). Each level of risk had its own procedure for all agencies to follow. The Commission were also advised of the Communications procedures within the Council following an incident of community tension. The ASB team would inform

- Cabinet Members
- relevant Ward Members
- minority party leaders
- Chief Officers
- other relevant Officers from:
 - Derby Homes
 - Housing and Advice Services
 - Youth Offending Team
 - Equalities.
