The Committee noted that this was the second time that the proposals had come before the Committee, the first of which committee objected to the large vertically illuminated letters being proposed, and that a revised scheme was being put forward with 3 tier letters with halo illumination, lights either side of the shop front and internal illumination above mullion level to the shop front.

Application No & 22/01114/FUL and 22/01115/LBA **Location** 6 Lavender Row, Derby, DE22 1DF

Proposals Single storey rear extension to dwelling house and installation

of replacement windows

22/01115/LBA single storey rear extension to dwelling house, internal alterations and installation of replacement windows

Resolved: no objection.

The Committee suggested reinstatement of sash to front elevation, second floor (instead of casement) and that the proportions and appearance of the extension doors could be improved by having a more slender frame and glazing bars and perhaps a different material e.g. metal to enable this.

Application No & 22/01196/FUL and 22/01197/LBA **Location** 4 Vernon Street, Derby, DE1 1FR

Proposal Change of use from offices to six apartments (Use Class C3)

and one 5 occupant house in multiple occupation (Use Class

C4)

22/01197/LBA Alterations in association with change

of use from offices to six apartments (use class C3) and one five occupant house in multiple occupation (Use Class C4)

Resolved: Objection

A previous proposal was presented at the 7th July 2022 meeting which was later withdrawn. The Committee agreed that in this case the heritage statement was poor with limited analysis of significance, HIA and no justification for each of the harmful works. Members had concerns about conversion to multiple flats in this street and a precedent being set. It was agreed that there had been a higher degree of change to the original layout previously within a previous proposal but, that there was still lack of detail and too much loss of historic fabric. The Committee agreed that the new scheme was still too harmful and impactful.

Chris Twomey left the room and Paul McLocklin took the Chair.

25/22 City Centre Vision – Emerging Ambition Document

The Committee received a report of the Head of Planning on City Centre Vision – Emerging Ambition Document.

It was reported that following consideration of the document at the last meeting, it was agreed that all CHAC members be invited to contribute individual comments upon it to the Vice Chair, who would then co-ordinate/collate these to ensure consensus.

It was noted that the Vice chair had collated members comments on the document and had produced an overall overview, which had been circulated to all members. It was also reported that all members were in agreement of it being submitted as their overall views.

Richard Carruthers, Senior Planning Officer, attended the meeting to answer any questions.

The Committee welcomed the fact that the council had recognised the need to construct a meaningful document and also recognised that this was the beginning of a process.

Members asked how the continuity of the plan would be guaranteed. It was reported that a delivery plan would sit parallel to this document and that it would be regularly reviewed.

Members noted that although there had been a need to compartmentalise the document for consultation purposes, but the different sections did strongly interlink.

Members asked the Senior Planning Officer what he saw as the central elements to making the city successful. He stated that in his view, there were two elements and that the first was "people" and the second was a public realm strategy.

Members felt that there was a lack of a cultural element to the document, of which heritage is a part. It was reported that a cultural masterplan was underway and that this would feed into it.

Resolved to agree that the collated document of member comments be submitted as the formal response of the Committee. Copy of these to accompany next CHAC agenda.
