Report of the Chair

Forward Plan: Monitoring and Tracking

# RECOMMENDATION

1. That the Commission consider whether to adopt a Forward Plan tracking and reporting system as agreed by the Scrutiny Management Commission.

#### SUPPORTING INFORMATION

2.1 At its meeting on 18 September 2007 members of the Scrutiny Management Commission expressed concerns about the level of compliance about the making of timely entries in the Forward Plan. As a consequence that meeting passed two resolutions:

Minute 47/07 Retrospective Scrutiny: 'resolved to include the Forward Plan as a standard retrospective scrutiny item at future meetings to ensure all reports were reported correctly and within the correct time frames'.

51/07 Council Cabinet Forward Plan: 'Resolved ... (2) To request a monthly analysis of Forward Plan items for items which do not appear in the Forward Plan for four months with an explanation of why not'.

- 2.2 Regulation 13 (2) of the Local Authorities (Executive Arrangements) (Access to Information) (England) Regulations states that a 'forward plan shall contain details of all the matters likely to be the subject of key decisions for a period of four months'. As an example, the January 2008 Forward Plan, published in December 2007, should include all key decisions where the earliest date for the decision is likely to be before 30 April 2008. The SMC resolutions mean that an explanation shall need to be provided for any key decision taken by Council Cabinet at any of the latter's meetings up to that scheduled for 22 April which has not appeared in the January Forward Plan.
- 2.3 The question for this Commission is whether it also wishes to adopt, with or without modification, the monitoring and tracking put in place by the SMC.
- 2.4 Analysis of the key decisions which relate to the portfolio of Children and Young People Commission since April 2007is set out below.

# Legal

The Forward Plan originates in primary legislation. Section 22 of the Local Government Act 2000 gave the Secretary of State the power to make regulations *requiring* prescribed information about executive functions to be made available to members of the public or members of the authority in advance of [key] decisions being taken.

The regulations made were the Local Authorities (Executive Arrangements) (Access to Information) (England) Regulations. Regulation 13 (2) of the Local Authorities (Executive Arrangements) (Access to Information) (England) Regulations states that a 'forward plan *shall* contain details of all the matters likely to be the subject of key decisions for a period of four months'.

The Forward Plan is not simply a bureaucratic legal requirement but is a key part of Derby citizens' entitlements. Article 3.2 of the Constitution says citizens have the right to 'find out from the forward plan what key decisions will be taken by the Council Cabinet and when'.

# **Equalities** impact

Timely entries in the Forward Plan are particularly important for the information to successfully circulate to hard-to-reach communities – either through socio-economic exclusion or not speaking English – who rely on word-of-mouth.
