45/13 Report on the Draft Local Plan, Part One Core Strategy

A report was presented by Planning Officers on behalf of the Strategic Director of Neighbourhoods which was entitled Consultation on the Draft Local Plan Part 1, Core Strategy. This is a new Local Plan for Derby which would eventually replace the existing City of Derby Local Plan review which was adopted in 2006.

The committee scrutinised the document and questioned the officers regarding the content of the report. They provided comments and feedback which the officers noted which is to be relayed to the Spatial Planning Team.

46/13 Report on proposed window options for Marble Halls, Nightingale Road

The committee received a report on Marble Halls, Nightingale Road, Derby presented by the Conservation Officer outlining a proposal for replacement windows. The proposal was to replace the inappropriate 1950's windows with windows that are similar to the proportions of the original design but are double glazed.

The committee discussed at length the history of window replacement in the Marble Halls and adjoining buildings, it was high lighted the committee had never granted permission to put UPVC (unplasticized polyvinyl chloride) double glazed units in a listed building before.

Resolved to:

- i) request the applicant come back to committee with a detailed design
- ii) reasons and justification why the current windows cannot be refurbished.
