 - set a timeframe for completing this review

SUPPORTING INFORMATION

- 2.1 Members of this Commission resolved at the January meeting to conduct a review on Children Looked After services. Following a presentation from the Assistant Director Children and Family Services and the Commissioning Manager for Social Services in February, members agreed the terms of reference shown in Appendix 2 at their April meeting.
- 2.2 Progress in completing this review has been rather slow due and therefore following the change in the composition of the Commission after July bye-election, Members were asked to confirm whether they wished to proceed with this review. Members considered the review of services to Children Looked After to be an important area of work and resolved to continue with the review but wished to revisit the Terms of Reference to ensure it was sufficiently focused.
- 2.3 The suggestion received from members are shown in Appendix 3.
- 2.4 Members are asked to give their suggestions for improving the current terms of reference and set a time table for completion of this review.

Review of Children Looked After Services

Terms of Reference for the Review agreed by Commission at 18 April 2005 meeting

The Commission will:

- To examine why there are high number of looked after children in the city compared with other similar sized authorities
- To examine the process of looking after children and consider whether the placements are effective, deliver good quality of service and outcomes for looked after children
- To consider ways of safely reducing the gap between Derby and similar sized authorities of the number of looked after children
- To understand the triggers for child protection register
- To evaluate the evidence and make recommendation to the Council Cabinet
