01/12 Welcome to New Members

Councillors Campbell, Whitby and F Winter were welcomed as new Members to the SACRE.

02/12 Appointment of the Chair

Resolved that Councillor Turner be appointed as Chair of the SACRE for the 2012/13 municipal year.

03/12 Appointment of the Vice-Chair

04/12 Apologies for Absence

Apologies for absence were received from Joan Price, Lucy Care, Rev Mrs Mair Bradley, Viv Lawrence, Alison Brown and Dr Phil Henry.

05/12 Late Items Introduced by the Chair

There were no late items.

06/12 Declarations of Interest

Councillor Campbell declared a personal interest as he was a member of the NASUWT.

07/12 Minutes of the Previous Meeting – 26 March 2012

The minutes of the meeting on 26 March 2012 were agreed as a correct record and signed by the Chair.

08/12 Matters Arising

There were no matters arising.

09/12 SACRE Vacancies

The Constitutional Services Officer summarised the current SACRE vacancies and talked to Members about the areas of the SACRE constitution that govern membership. He proposed that all nominating bodies be contacted to re-nominate existing Members or to nominate new representatives. He also proposed that amendments be made to the SACRE constitution, such as a term of office being decided for co-opted Members.

Resolved that:

- the Constitutional Services Officer bring a report on membership and vacancies to the next SACRE meeting; and**

- **the Constitutional Services Officer bring a report on recommended changes to the SACRE constitution to the next SACRE meeting.**

10/12 SACRE Action Plan

Members discussed progress made on the three actions from the SACRE action plan:

1. Clarify SACRE roles and responsibilities and how these can be met.
2. Make a document for schools, professional associations and faith groups to detail SACRE roles and responsibilities (established as part of Action 1) and explain lines of communication.
3. Build close relationships with schools.

Members noted that progress had been made and agreed that the working party established at the November meeting should carry on.

Resolved to agree that the working party carry on working on the completion of the three actions in the SACRE action plan.

11/12 School Visits and Induction for SACRE Members

Members received feedback on the recent school visits training for SACRE Members that had taken place at Chellaston Academy. Thanks were given to Christine Smith and her team at Chellaston Academy. Thanks were also given to all the SACRE Members who attended the first training session.

Members noted that the next school visits training would take place in the autumn. Maxine Bull, as Head Teacher of St Chad's Church of England Nursery and Infant School, volunteered her school for the autumn training. The Inclusion Manager explained that he would put a note in the General Circular asking for other schools to volunteer to allow further training sessions to take place. It was agreed that Viv Lawrence would continue to organise the school visits training.

Members agreed that a letter to visit a school needed to come from the Local Authority and that once Member training had been completed the selection of schools would be random.

Members approved, with minor amendments, the three guidance documents for school visits.

12/12 Letter to the Chair of the All Party Parliamentary Group for Religious Education

The Inclusion Manager explained to Members that the All Party Parliamentary Group (APPG) on Religious Education (RE) had been set up as a result of RE being omitted from the English Baccalaureate. Members noted that, as agreed at the last meeting, a letter had been sent from the SACRE to the Chair of the APPG. The letter outlined the SACRE's concerns over how RE is taught in academy schools. Resolved to agree that any short articles to be included in the annual SACRE report be sent to Graham Falgate by Friday 17 August 2012.
