AQAP	Air Quality Action Plan	An Air Quality Management Area (AQMA) is an area where the annual average concentration of air pollutants is currently predicted not to meet national set targets. It is a requirement that in the areas, an Air Quality Action Plan must be produced
CAA	Comprehensive Area Assessment	Comprehensive Area Assessment (CAA) is the new assessment framework, to be delivered from April 2009, that will provide a snapshot of how effectively local partnerships are working together to deliver local people's priorities
CCTV	Closed-circuit television	Closed-circuit television (CCTV) is the use of video cameras to transmit a signal to a specific place, on a limited set of monitors. Many cities and motorway networks have extensive traffic-monitoring systems, using closed-circuit television to detect congestion and notice accidents
DATM	Derby Area Transport Model	DATM is a multi modal transport model, which can model several different types of transport mode and then assess how these interact with each other. DATM allows us to analyse the transport problems within Derby Joint LTP area on a holistic basis

NMD	Network Management Duty	The Network Management Duty places a duty on Local Transport Authorities to manage their road network with a view to achieving, so far as may be reasonably practicable having regard to their other obligations, policies and objectives, the following objectives-(a) securing the expeditious movement of traffic on the authority's road network; and, (b) facilitating the expeditious movement of traffic on road networks for which another authority is the traffic authority."
NMP	Network Management Plan	The Network Management Plan is a technical document which specifies the maintenance and repair standards for the authority's roads
PFI	Private Finance Initiative	The private finance initiative (PFI) provides a way of funding major capital investments. Private consortia, usually involving large construction firms, are contracted to design, build, and in some cases manage new projects.

RFA2	Second Regional Funding Advice	This second round of advice on regional investment priorities relating to transport, housing and regeneration, and economic development up to 2019 based on an indicative funding allocation. The region submitted its advice to Government by the end of February 2009
RMRA	Rosehill Market Renewal Area	Rosehill Housing Market Renewal Initiative – this Government funded project relates to an area of terraced housing in relatively poor condition and suffering from low demand.
RSG	Road Safety Grant	The road safety grant replaces the previous system of funding safety cameras through fine income. From 1 April 2007 safety cameras were integrated into the local transport plan system and authorities have greater flexibility to use this grant to implement any locally agreed mix of road safety measures
RSS	Regional Spatial Strategy	The Regional Spatial Strategy (RSS) provides a broad development strategy for the East Midlands up to 2021. It also represents the spatial element of the East Midlands Integrated Regional Strategy (IRS).
RTI	Real Time Information	Passenger information is provided to public transport users. Real time information, changes continuously as a result of real-world events and is typically used during the course of a journey (primarily how close the service is running to time and when it is due at a stop, but also incidents that affect service operations, platform changes etc).
RTS	Regional Transport Strategy	The Regional Transport Strategy (RTS) is part of the RSS and aims to integrate land-use planning and transport planning to steer new development into more sustainable locations, reduce the need to travel and enable journeys to be made by more sustainable modes of transport.
s106	Section 106 Agreement	Section 106 (S106) of the Town and Country Planning Act 1990 allows a Local Planning Authority (LPA) to enter into a legally-binding agreement or planning obligation with a land developer over a related issue. The obligation is termed a Section 106 Agreement.
SRTS	Safe Routes to School	Safer Routes to School is a project that aims to encourage and enable children to walk or cycle to and from school. This is achieved through the introduction of targeted traffic calming and the creation of safer walking and cycling routes.
TRO	Traffic Regulation Order	A Traffic Regulation Order (TRO) is a legal order, which allows the Highways Authority to regulate the speed, movement and parking of vehicles and regulate pedestrian movement, which are enforceable by law. The act governing Traffic Regulation Order's is the Road Traffic Regulation Act 1984.

UTC	Urban Traffic Control	The Urban Traffic Management Control, UTMC or Urban Traffic Control, UTC, programme is the main initiative of the UK Department for Transport (DfT) for the development of a more open approach to Intelligent Transport Systems or ITS in urban areas. UTC systems are designed to allow the different applications used within modern traffic management systems to communicate and share information with each other. This allows previously disparate data from multiple sources such as ANPR cameras, Variablemessage sign (VMS), car parks, traffic signals, air quality monitoring stations and meteorological data, to be amalgamated into a central console or database. The idea behind UTMC is to maximise road network potential to create a more robust and intelligent system that can be used to meet current and future management requirements.
VAS	Vehicle Activated Sign	Vehicle activated signs (VAS), are road side digital signs that display a message when they are approached by a driver exceeding the speed limit or going too fast for the type of road, especially when there is a hazard, e.g. a bend or a crossroads.
