1. DER/10/09/01255

Change of use and extension of storage building to form boxing club at unit to the rear of 4 Poplar Avenue, Spondon, Derby

Mr Thorpe and Councillor Williams addressed the Committee in objection to the application .

Resolved to refuse the application for planning permission.

Reasons

Proposed alterations and extension to building to form boxing club would have an overbearing and dominant impact on the rear garden and habitable room windows of the adjacent dwelling at 4 Poplar Avenue, by reason of scale, height, massing of the development and its location on the rear boundary of the property. It would result in a significant loss of amenity for the occupants of the neighbouring dwelling and, therefore, be contrary to policies GD5 and E23 of the adopted City of Derby Local Plan Review.

Councillor Harwood was nominated to represent the Council on any future

appeal.

2. DER/03/10/00383

Erection of 14 dwellings and the formation of access at the site of the former Palm Court Restaurant, Duffield Road, Derby

Mrs Hudson, Mr Knight and Councillor Davis addressed the Committee in objection to the proposal.

Resolved to refuse the application for planning permission

Reasons

- A. The proposed development would be over intensive and appear cramped in the streetscene, by reason of the number of dwellings, scale and height of the built form and layout, resulting in a scheme, which would be visually intrusive in a prominent location in the locality and out of character with the type and layout of housing in the surrounding residential area. It would, therefore, be contrary to policies H13, GD4 and E23 of the adopted City of Derby Local Plan Review.
- **B.** The layout, massing and scale of the development would have an overbearing impact on the living conditions of nearby residential properties in Devonshire Avenue and Kings Croft, resulting in an unreasonable loss of amenity for local residents. The proposal would, therefore, be contrary to policies GD5 and H13 of the adopted City of Derby Local Plan Review.

Councillor Hickson was nominated to represent the Council on any future appeal.

3. DER/04/10/00455

Change of use from offices (use class A2) to hot food takeaway (use class A5) on the ground floor and residential (use class C3) on the first floor and the erection of a staircase to the rear at 1255 London Road

Councillors Graves and L Winter addressed the Committee in objection to the proposal.

Resolved to grant planning permission with the conditions contained in the report

4. DER/06/10/00647

Extension to dwelling house (study, w.c., bathroom, bedroom, en-suite and enlargement of kitchen and dining room) at 5 Chelwood Road, Chellaston, Derby

Councillor Holmes addressed the Committee in objection to the proposal.

Resolved to grant planning permission with the conditions contained in the report

Erection of a 2.4m high boundary fence and store at St. Werburghs C of E

School, Church Street, Spondon, Derby

An amendment to condition five to take into account revised plans was reported at the meeting.

Resolved to grant planning permission with the conditions contained in the report

Conversion of a Magistrates Court building to form offices at the former Derby and South Derbyshire Magistrates Court, Derwent Street, Derby
