

Report of the Strategic Director of Neighbourhoods

Amendment of Private Hire Driver, Hackney Carriage Driver and Private Hire Operator Conditions

SUMMARY

- 1.1 The condition relating to convictions with regard to private hire drivers, hackney carriage drivers and operators refers only to conviction and not; Criminal Convictions, Cautions, Reprimands and/or Warnings as detailed on the application/renewal forms.
- 1.2 This inconsistency has led to confusion within the trade as to what they need to report to the Licensing Team.
- 1.3 To clarify the situation and avoid any confusion or misunderstanding the wording on the conditions attached to any licence needs to reflect the wording on the application/renewal to ensure that officer/members have all the relevant information they need to determine if a driver or operator is 'fit and proper' to hold a licence.

RECOMMENDATION

- 2.1 To amend condition 19 of the Private Hire Driver Conditions and Hackney Carriage Driver Conditions to; Criminal Convictions, Cautions, Reprimands and/or Warnings -The driver shall, within 14 days of the date of receiving or having imposed on them any Criminal Convictions, Cautions, Reprimands and/or Warnings, disclose to the Council in writing, details of the Criminal Convictions, Cautions, Reprimands and/or warnings during the period of the licence.
- 2.2 To amend condition 25 of the Operators conditions to; Criminal Convictions, Cautions, Reprimands and/or Warnings – The Operator shall, within 14 days of the date of receiving or having imposed on them any Criminal Convictions, Cautions, Reprimands and/or Warnings, disclose to the Council in writing, details of the Criminal Convictions, Cautions, Reprimands and/or warnings during the period of the licence.

REASONS FOR RECOMMENDATION

3.1 To ensure that officers/members have all the relevant information they need to determine if a driver or operator is 'fit and proper' to hold a licence.

4.4 Currently Condition 19 of the private hire driver conditions and hackney carriage driver conditions state: Convictions - The driver shall, within 14 days of the date of any conviction, disclose to the Council in writing, details of the conviction/s imposed on them during the period of the licence.

- 4.5 It is therefore proposed that condition 19 of both the private hire and hackney carriage driver conditions is changed to; Criminal Convictions, Cautions, Reprimands and/or Warnings The driver shall, within 14 days of the date of receiving or having imposed on them any Criminal Convictions, Cautions, Reprimands and/or Warnings, disclose to the Council in writing, details of the Criminal Convictions, Cautions, Reprimands and/or warnings during the period of the licence.
- 4.6 Currently Condition 25 of the Operators Conditions state: Convictions The operator shall within 14 days disclose to the Council in writing details of convictions imposed on them during the period of their licence.
- 4.7 It is therefore proposed that condition 25 of the Operators conditions is changed to; Criminal Convictions, Cautions, Reprimands and/or Warnings – The Operator shall, within 14 days of the date of receiving or having imposed on them any Criminal Convictions, Cautions, Reprimands and/or Warnings, disclose to the Council in writing, details of the Criminal Convictions, Cautions, Reprimands and/or warnings during the period of the licence.
