



## Area Panel 2 Budget Proposals 2007/8

### SUPPORTING INFORMATION

- 1.1 The Area Panel budget allocation for 2007/8 is £23,292. The Panel has an additional budget of £1,049 carried forward from 2007/8. Nil returned, unspent funding from previous years means that a total budget of £24,341 is available for allocation to projects during this financial year. The allocation is split by ward.
- 1.2 The area panel is asked to consider whether to support applications received. A short summary of each project is attached to this report in Appendix 2.
- 1.3 A summary of applications funded for the current financial year is provided in Appendix 3
- 1.4 The area panel is asked to consider whether to support the Tree Management proposals as set out in Appendix 4. There are no works proposed.
- 1.5 The Council Constitution states that the Area Panels can 'use a delegated budget for local environmental and community purposes'. Therefore, if an application does not specifically refer to a local activity, consideration needs to be given to the appropriateness of allocating area panel funding to the project. In deciding whether to support each application, the area panel will assess the funding request against the funding criteria and its priorities.
- 1.6 The funding criteria state that applicants need to provide a service in response to the needs of local residents and meet at least one of the following criteria:
  - improve access for local people to existing services
  - provide a service in response to an issue raised in a community update report
  - contribute to improvements which will provide a benefit to local residents
  - assist in providing an integrated service in response to an issue raised at an area panel meeting
  - enable residents to participate in their community or at area panel meetingsApplications also need to:
  - provide evidence of need for the application
  - show evidence that ongoing maintenance or revenue costs have been approved by the relevant Council department, if necessary.
- 1.7 The priorities for supporting an application are that it:
  - is from a voluntary or community group
  - shows evidence of match funding or self help
  - provides a service in response to the needs of local residents
  - will directly benefit people living in the geographical area panel
  - shows evidence of how the project will be sustained beyond the period of funding, if it is not a one-off project
  - contributes to the delivery of one or more of the Council's corporate objectives.
- 1.8 In most circumstances, the amount of funding that the area panel will award to an applicant will be between £50 and £2,000. However, the area panel does have the discretion to award more if it considers the application to be a priority for the area.



1.9 If the funding applications are approved, the implications for the total budget for Area Panel 2 in 2007/08 will be:

## **Appendix 1: Summary of implications**

### **IMPLICATIONS**

#### **Financial**

- 1.1 Area panels must consider priorities within the area when considering requests for funding. Not all requests that meet the criteria will be considered a priority. When supporting or rejecting an application over £25,000, Area Panel 2 must give reasons for its decision.

#### **Legal**

- 2.1 Area Panel 2 has delegated authority to use its budget for local environmental and community purposes.
- 2.2 Section 19 of the Local Government (Miscellaneous Provisions) Act 1976 empowers the Council to offer grants to voluntary and other organisations to provide any recreational facilities.
- 2.3 Any decision involving the making of a grant or loan over £25,000 to any voluntary body is deemed to have a significant impact on two or more wards and is therefore a key decision.
- 2.4 After a key decision has been taken, the Corporate Director of Corporate and Adult Social Services and Deputy Chief Executive must publish a record of every executive decision taken at that meeting within two days of that meeting. The record must include a statement of the reasons for each decision and any alternative options considered or rejected at the meeting. No action will be taken on any such decision for five clear days from the date of publication.

### Officer Advice

#### Approve (Partial)

The project provides a benefit to the community of Chellaston and contributes to the cultural heritage in Derby. However, given the number of applications submitted to the Area Panel, there is limited funding. Therefore, a partial award of the funding is recommended.

### Description

Chellaston History Group has been in operation since February 2000. The group consists of mainly elderly retired residents of Chellaston ward. The group is focused on recording the history of the area. The aim of the group is to publish and disseminate historical information about the area to the wider community. The group collects documents, photographs, interviews, newspaper articles and any other materials that support the collection of historical information about the Chellaston area.

The group is seeking funds to purchase a range of equipment for their exhibitions and presentations. They are also seeking funds for vital recording equipment and a quality PA system, as a means of supporting residents with a disability. The group hopes that the new equipment will broaden their exhibitions and presentations and thus encourage new members. The project will:

*Improve the quality of life in Derby's neighbourhoods by:* Up to 1,000 people will benefit from the project. The project helps to engender a sense of civic pride by celebrating the history of the Chellaston area. Previous exhibitions have involved local Churches, schools, Brownies and Scouts' groups and the Dance club.

*Giving you excellent services and value for money:* - The group is served by volunteers. Their exhibitions and presentations are used by a variety of groups and individuals in the area. The proposed equipment will be used for local people reminiscing, presentations and exhibitions. The group provides funds for its running costs through fund raising and subscriptions.

*Improve access for local people to existing services by:* Bringing together elderly persons in the area.

*Sustainability of the project:*

One off project. The funding is being sought for equipment to aid the development of the group. The group has a record of fundraising activity and members pay subscriptions to support the operation of the group.

#### Officer Advice

##### Reject

The application was deferred at the last meeting as advice from the Burglary Reduction team is that other options need to be explored prior to the purchase of CCTV equipment. It was recommended that the use of the existing gates would reduce the levels of theft and anti social behaviour. There has been insufficient time to assess whether this has been undertaken and/or if this has made an impact on the situation. The residents can make an application to the Alvaston Neighbourhood Board in the future should there still be a problem.

#### Description

Residents need to identify the people who are entering the park and stealing garden ornaments, garden furniture and breaking into homes and stealing property. This project is to install CCTV at the entrances to the Park. The cameras if installed will run on broadband they will be monitored by myself, The monitor will be my PC. For access a password will be required.

No training is required; the applicant has 11 years experience in security as chief security officer for a large company in Derby. A diary log will be kept which will be locked away in a cupboard, only officers have keys to this cupboard.

Data Protection will not apply as there will be no pan, tilt or zoom. The cameras will be focused correctly by the installer so that they cannot interfere with other properties, so will not contravene the Data Protection Act 1998.

At the moment the gates are open from 7am to 7pm, and are locked from 7pm to 7am. The applicant will try to get the gates locked from 4.30 pm to 8 am. Because of the lighter nights they consider that they need the gates locked for longer periods. At present the gates are locked 24hrs during all school holidays, during the locked periods a key card is needed to enter this site but the people we are trying to stop actually climb over the gates, the cameras would be there to assist the police to recognise the people who are climbing over the gates during the times when the gates are locked.

173 Homes people are expected to benefit from the grant, of which 100% live in the area.

*Evidence of need:* After a number of meetings the problems of people entering the area being abusive to residents, garden ornaments being damaged or stolen, break-ins of homes property and cash stolen, we realise that is these people want to get in they will. The area is peaceful and quiet majority who live here are elderly, some are disabled, we also understand that the police do not have the resources to give us the cover we need to stop these people, with the cameras we will be able to give the police the evidence they need to take action against these crimes.

The project will:

*Build healthy and independent communities by:* The project will help to provide a safer environment for the residents.



*Contribute to environmental improvements which will provide a benefit to local residents by:* This will help to benefit all the residents on the park they will feel safer in their homes, also feel safer to leave their homes when they go out or go away on holidays. Knowing that someone is there looking out for the criminal element in our society.

*Assist in providing an integrated service in response to an issue raised at an area panel meeting by:* This has been raised at our local Neighbourhood watch meetings; we have also undertaken a complete perimeter check with a crime reduction officer and a report has been made.

*Enable residents to participate in their community or at area panel meetings by:* This will certainly help residents to participate in their community.

*Sustainability of the project:*

This project will assist the police to recognise these persons and hopefully lead to arrests being made. Any ongoing costs will be taken care of by members of the watch with their donations at our meeting. Each member pays £1.50 per meeting £10 of which pays for the hire of the hall. Other fund raising ideas will come along for instance a barbeque selling hot dogs and refreshments.

<p><b>Partially Approve</b> The group was established in March of this year and is a small voluntary organisation. Given the number of applications a partial approval is recommended. However, they should also seek to work with Derby CVS in terms of developing their organisation and seek funds through the Local Network Fund and form strong links with Children and Young People's Services.</p>

## Description

The project is seeking funds for the establishment of a pre school in the Shelton Lock area. The project aims to benefit 12 children and their families, all of whom will reside in the Shelton Lock area of the ward.

The project is being developed following research and consultations with parents and the local schools – Shelton Lock Infant, Nursery and Junior schools. The Nursery and Infant schools has highlighted the need to improve the transition and admission into nursery schools. Parents have showed an enthusiastic support for the project – with over 80% expressing an interest in using the service.

The funding will provide start up equipment and resources for the playgroup. It is estimated that up to 20 children will use the play group.

<p><b>Approve (Partial)</b></p> <p>The funding would enable the much needed renovation of their building. However, the project is a large scale capital project and the Area Panel is not in a position to fully support the application given the limited amount of funds available and high volume of applications.</p>

## Description

The project will:

Provide improvements and an extension to the existing premises of the 91<sup>st</sup> Derby Scout Group's premises. The premises are used extensively throughout the week. On average, 200 people a week make use of the centre. These people are mainly members of the scout groups and the volunteers.

The funding will enable disabled access to the main building and the provision of a disabled toilet in the existing outhouse and then finally, to link the two buildings thus resulting in a fully accessible premises with full disabled access toilets facilities.

The premises are used by the Rainbows, Beavers, Cubs, Brownies and guides for their weekly meetings. However, the facilities prohibit children with disabilities using the premises, therefore, the group wishes to complete the work as a matter of urgency to enable full disabled access to the premises.

**Partially approve** – The project responds to an identified need in the area. Joint partnership work has been undertaken and it is hoped a contribution can be secured from partners such as the Police, Derby Community Safety Partnership and the Neighbourhood Teams. Therefore, partial approval is recommended.

**Description**

The purpose of the project is to direct a police led campaign to combat the misuse of mini motor bikes and trail bikes in the Allenton, Alvaston and Boulton areas. By concentrating efforts in policing this problem we hope to dramatically reduce the ASB caused by them. The intention is to identify individuals causing the problems issuing warnings & possible prosecution as well as confiscating/ seizing vehicles with no insurance etc.

Complaints of the misuse of mini motorbikes and trail bikes both along the Allenton/ Shelton Lock Canal path and at Alvaston Park have been directed to both ward councillors and the police consistently over the past couple of years. Over the past 3 months alone the police have received 42 calls for service in relation to this matter. Many other calls were also logged under different headings but still relating to this problem. Over the past 6 months the problem has escalated at an alarming rate. Concern on this issue has been brought up at Community panel meetings, councillor surgeries, neighbourhood watch meetings and tasking meetings.

**Partially approve** – the project is based in Chellaston ward, however some of the users reside in Boulton ward. Depending on the allocations made to other project applications at the meeting, there is insufficient funding within the Chellaston ward allocation. Therefore, partial approval is recommended. The project helps to improve relations within the community and offers an opportunity for people to improve their health and well being. However, allocation of funding should be subject to the group providing a quote for the portacabin, permission for installation of the portacabin and a copy of their equal opportunities policy.

#### **Description**

The project is seeking funds to help improve the facilities available at their allotment site. There are a total of 86 plot holders and their families who use the site. This equates to approximately 250 people with an average of 3 people associated with each plot. It is expected that 95% of the beneficiaries of the project live within the Area Panel 2 area.

The allotment users have recently created a grassed area with a set of young trees. They would like to expand this area to enable it to be used by members and their families while using the allotment site. The intention is to expand the area for the use of BBQ, Picnic areas, Putting Green, Swings, etc. In addition, there is a need for Porta cabin/toilet facilities for female users of the allotment.

The allotment has been very successfully, recently awarded most improved site in the 2006 Derby in Bloom competition. The Portacabin can also be used as a meeting space for the users of the site.

<b>Partially approve</b> – the project meets the Area Panel criteria and provides a positive benefit to residents. However, due to the volume of applications there is insufficient funding to support the project.

## Description

The project has recently been established and is supported by BTCV (formerly known as the British Trust for Conservation Volunteers).

Osmaston Green Gym is a newly formed self sustaining community group. The green gym provides a regular programme of physical activities that take place outdoors and through which the members improve their local environment by practical action. The sessions are led by local volunteers and are designed to improve participant's physical and mental health.

Sessions last between two and four hours and people are encouraged to attend at least once a week. Membership is free and each session caters for mixed ability groups. There are also regular sessions with Merrill College and one off sessions with Nightingale and Allenton Primary Schools.

The group is applying for area panel funding to set up a tool store, additional tools, essential training for volunteer leaders and publicity brochures.

Over the last 2 years whilst the green gym was facilitated by BTCV the project has delivered 205 sessions with 1228 volunteer work days. 90% of the current volunteers are from the local area. The group is made up of people with mixed physical and mental abilities. Participants have seen an improvement in their wellbeing and are encouraged that they are improving their local green space and allotment site. Local residents commented at the recent Go Wild event that Osmaston Park was much improved and a lot nicer to visit.

#### **Officer Advice**

**Partially approve** – The project is based in Alvaston ward, however it does serve a city wide function. A large proportion of their users live in the Area Panel 2 area and the group provides a resource/community based project within the neighbourhood. The group has limited options in terms of funding support.

#### **Description**

The organisation is located on part of the old RAF Alvaston base. The group operates through the support of 19 volunteers who come from the RAF Volunteer Reserve, all of who live in the Derby area.

The project is seeking assistance to purchase additional and replacement equipment for their catering facilities and similarly to upgrade their climbing equipment.

The catering group provide much needed support during weekend training activities on site at Alvaston, during adventure weekends away and also on extended camps. They also cater for social functions on site, for example, the Valentine's dinner, a formal 'Dining in' night for staff and guests and Open Day events.

The current equipment is over ten years old and the mobile ovens are becoming dangerous. The group is also short of benches and tables, and catering and cooking equipment.

In addition, the climbing equipment is at the end of its recommended safety life of five years. The following equipment needs to be replaced: Rope, Harnesses and helmets and Ancillary equipment.

The above equipment is used on a regular basis both on expeditions and on site through the use of their own climbing wall.

The organisation provides a service for 100 cadets, with the potential to increase to 150 cadets. The Squadron provides training for the young people that will be useful in civilian life and they also have the opportunity to pursue the Duke of Edinburgh Award scheme. By providing a range of activities, the Squadron enables the young people to have a sense of worth and value.
