As the table shows, of the 129 waivers, 101 were considered to be unavoidable.

This compares with 110 waivers that were considered by Audit and Governance Committee on 24 March 2021 for the period 1 July 2020 to 31 December 2020. Of that 110, 89 were considered to be unavoidable.

- 4.2 All avoidable waivers over £10,000 are reported at appendix 1. Each waiver is signed off by the relevant Director stating they agree with the recommendation.
- 4.3 A waiver is required if the relevant process outlined in the Council's Contract Procedure Rules for awarding a contract cannot be followed.
- 4.4 Of the unavoidable waivers, 10 were unavoidable due to Covid-19 relating to Supported Accommodation and Homecare
