# 06/09 Minutes of the Inquorate meeting Held on 16 March 2009

# 08/09 Reflections on the new RE Agreed Syllabus and launch – discussion

Graham Falgate asked SACRE to provide feedback on the RE Agreed Syllabus Launch Event.

Mair Bradley commented that that launch was a really good morning and it was great to see the impact in schools. Mair stated that many participants she had spoken to had been full of praise for the syllabus and had also borrowed copies of the document.

Resolved to note the success of the RE Agreed Syllabus Launch.

# 09/09 Annual SACRE Report – discussion

Graham Falgate asked SACRE to provide reflections for the Annual SACRE Report. He reported that the document would be produced in the autumn term and that previously SACRE had provided an input. Graham asked for

### 10/09 QCA Glossary of terms

Graham Falgate asked SACRE for their comments on the Religious Education: Glossary of Terms. He reported that the document was published by the School Examination Council and was a comprehensive glossary for all major faiths.

SACRE noted that no faith had tried to define GOD but that the glossary was very detailed and there were no objections from any group.

Resolved to accept the QCA Glossary of terms.

### 11/09 SACRE website and contact details – update

Mike Lake informed SACRE that the glossary of terms used in Religious Education which he had produced was still on the SCARE website but as a result of overwhelming opposition to it by SACRE members he no longer wished to run the website. He felt that to not allow the document was undemocratic and it would be against his principals to continue to manage the website. Mike informed SACRE that he would provide the website on a disc for another member to continue if they so wished.

Graham Falgate thanked Mike on behalf of SACRE for all his work on the website. Graham explained that the glossary would be removed from the website when Mike provided the disc and it was clear what needed to be done technically.

# 12/09 The Open Centre – survey of student attitudes

Mike Lake informed SACRE that The Open Centre was moving to St James Centre on Saturday 1 August 2009. The group have the ground floor of the centre for three years but it was felt that the space was in the wrong location as it was <sup>3</sup>/<sub>4</sub> mile from its current location. It was reported that there was support from the Council to find long term accommodation, possibly within the Normanton Mills site.

Mike informed SACRE that The Open Centre was getting increasingly busy and that the group were developing their services with twilights events. It was suggested that SACRE receive a presentation on the work that The Open Centre was doing at the meting meeting.

# Resolved to receive a presentation on The Open Centre's work at the next scheduled meeting of SACRE.

### 13/09 Any other business

SACRE shared details of their knowledge and experience of SACRE to each other on their faiths.
