# 69/13 Pre- application advice at Friar Gate House Friar Gate

The Committee received a report furnishing them with pre-application advice regardingFriar Gate House, Friar Gate. Friar Gate House site was until recently the site of the former Friar Gate House school. Built in the 18<sup>th</sup> century it is one of the city's important collection of Georgian Town Houses and is grade II listed. It is currently undergoing conservation and restoration works to restore it to a single townhouse.

When undertaking works internally within the front bay it could be seen that the original building had been extended in the 19<sup>th</sup> century adding a bay window onto an earlier Georgian stone colonnade/ bay type structure. Opening up

works exposed rotten timber supports within the bay which had to be removed. Although brick on the inside it was thought to be stone/ stucco on the outside. Therefore it was hoped that this could be repaired in situ. This is not the case and it would appear that the 19<sup>th</sup> century bay is somewhat of a bodged job and was not tied into the Georgian element with anything more substantial than the fill and paint. In addition due to its poor construction it is now close to collapse being unable to support the weight of the structure above. The owner wishes to proceed as quickly as possible and wants guidance before commissioning an architect to draw up a scheme.

Resolved to raise no objections to the proposalif restoration of the existing bay window structure is not possible. It was suggested that a listed building application is submitted for the alterations proposed, with reasons why restoration is not feasible and detailed designs be submitted for consideration. It was suggested that Highfield House is looked at as regards general design and the details for glazed infill panels.

## 70/13 Derby Centre Townscape Heritage Initiative

The Board were presented with a report of behalf of the Strategic Director of Neighbourhoods, Derby Centre Townscape Initiative which gave an overview of a new scheme which was launched on Thursday 3<sup>rd</sup> April, 2014.

The scheme is funded with over £700,000 from the Heritage Lottery along with approximately £200,000 from Derby City Council. The scheme is a grant scheme so this will mean that there will be some private investment by the owners of the historic buildings within the eligible area which will bring the total investment in the area to approximately £2 million. The scheme will run for the next 5 years.

The scheme will repair, sympathetically restore and enhance historic features of buildings on Green Lane and neighbouring streets. It aims to bring back empty shops into use and help the area's regeneration.

Through this scheme it also aims to improve a small amount of pavements, give advice to businesses within the area and provide training opportunities in traditional skills targeted at students, building owners and contractors. It is also intended to develop local history events to help people appreciate their local area and the opportunity for practical conservation work to be seen in progress by children and young people.

To deliver this scheme the City Council will continue to work closely with Derby's two Business Improvement Districts and the owners and occupiers within the area.

Resolved to note the report but also suggested that instead of public realm improvements to the pavements on Green Lane or at The Spot that funding was instead spent on improving the Macklin Street/ Green Lane junction. The

Committee requested the Conservation Officer raise this at the next Townscape Heritage Initiative Board meeting.
