2022/23 Inspections Update

Purpose

- 1.1 Local authorities are responsible for providing a range of services that are assessed as vital for an area.
- 1.2 As part of the delivery of services, in some areas, regulators have been given the powers to inspect services to determine the overall quality, and whether these are having a positive impact on the lives of people within the local area.
- 1.3 The purpose of this report is to provide an update on external inspections and assessments that have been undertaken of local authority services between April 2022 and March 2023.

Recommendations

- 2.1 To note the inspections completed over the last year, or reports published from inspections carried out at the end of the previous year.
- 2.2 To note the regulatory developments in inspection activities set out in paragraph 4.6.

Reason

3.1 The Audit and Governance Committee is a key component of the Council's corporate governance. It provides a high-level focus on the audit, assurance and reporting arrangements that underpin good governance and financial standards; which includes the findings of independent regulators.

Supporting information

4.1 The inspections of services delivered by local authorities are undertaken in line with government acts, where regulators will have been given the powers to undertake a review of specific areas of delivery.

- 4.2 In March 2022, Ofsted completed their inspection of Local Authority Children's Services, with the report published in May 2022, with an overall judgement of 'outstanding', with all sub-judgements being maintained or improved compared to the previous inspection...
 - The impact of leaders on social work practice with children and families outstanding
 - The experiences and progress of children who need help and protection outstanding
 - The experiences and progress of children in care and care leavers good

- 4.4 In June 2022, Ofsted undertook an inspection of Derby City's Adult Learning Service, where the overall effectiveness was judged to be 'good', which is a position that has been maintained from the previous inspection. Services were assessed as good across all judgement categories...
 - The quality of education good
 - Behaviour and attitudes good
 - Personal development good
 - Leadership and management good
 - Adult learning programmes good
 - Apprenticeships good

- 4.7 Alongside formal regulated inspections Derby City also participates in regional sector led improvement activities. There were no peer reviews completed in 2022/23.
- 4.8 It should however be noted that Derby Homes have had an independent review of customer standards completed in 2022/23, the findings of which are reported through their governance arrangements.
- 4.9 The aim of this report is to report at a service level and not to report on the inspection outcomes of individual provider services (i.e., maintained schools, Children's Homes and Care Providers), as these are already reported through established routes.
- 4.10 Children's Homes are regulated and inspected by Ofsted as required by the Care Standards Act 2000. Inspections are based on the Children's Homes (England) Regulations 2015 and Quality Standards. Every Children's Home is inspected at least twice a year, receiving one full and one interim inspection. The outcomes of these are reported to Corporate Parenting Committee.


