Update on the Implementation of Commitments Regarding the Pledge for Children in Care 2017/18

SUMMARY

- 1.1 The Pledge is a promise made by Derby City Council to all children in their care. The Pledge is part of Derby's commitment to give children in their care the best opportunities they can have in life.
 - Since the launch of the new Pledge in January 2016 significant progress has been made by departments in developing, improving and embedding services for children in care.
- 1.2 The Corporate Parenting Committee has worked to ensured that the whole Council is fully committed to the Pledge. To review progress and overview the Corporate Parenting Committee has received regular updates and monitored progress of each department's commitments.
- 1.3 In 2016 the Corporate Parenting Committee held two pledge evening events, one on 5 July in the Council Chamber and the other on 14 December in the Mayoral Reception Room. The Pledge evening events received formal updates about the progress made by each department and directorate on the Pledges made back in January 2016 at the launch of the Pledge.
- 1.4 For 2017/18 it has been agreed to continue with the Pledge events. The most recent Pledge event was held on 11 July 2017

The Corporate Parenting Committee will undertake further progress monitoring of the Pledge commitments throughout 2017/18.

The Chair of Corporate Parenting Committee will provide an oral update at the meeting from the event.
