## 32/11 Committee Report

### **Friar Gate Conservation Area**

**Application No.** DER/07/11/00873 & DER/07/11/00874 - 21-23 Friar Gate, Derby, DE1

**& Location:** 1BX (Almanac PH)

**Proposal:** Retention of display of 3 externally illuminated fascia signs, 1 internally

illuminated projecting sign and 1 externally illuminated high level sign

The Committee recommended refusal on the grounds that the two outer fascia signs (either side of the main Almanac sign) introduced visual clutter which adversely affected appearance. Members accepted the lighting on the 3 fascia signs but requested that the projecting box sign be a hanging swinging sign and be externally illuminated . It was requested that the gable sign not be illuminated as floodlighting would produce abnormal light on this elevation as there was a good level of external lighting already. .

#### Others - not in Conservation Areas Conservation Area

**Application No.** DER/05/11/00515 - Site of California Works, Parliament Street, Derby,

**& Location:** DE22 3RT

Proposal: Residential development (8 dwelling houses, 6 apartments and

formation of car park)

The Committee recommended refusal on the grounds that the quality of design at the gable end was unacceptable, bearing in mind its proximity to St Luke's Church. Members requested that the developer be asked that the historic association and name of the site be continued by suitable items on and within the new development, for example cast iron gates. It was confirmed by officers that this could be done by an informative note.

#### Others - not in Conservation Areas Conservation Area

**Application No.** DER/07/11/00883 - Land at 146 Chaddesden Lane, Chaddesden,

**& Location:** Derby, DE21 6LJ

**Proposal:** Erection of one dwelling with associated means of access

The Committee agreed to repeat their comments that were made on the previous application for this site (DER/08/10/00997).

The committee raised no objection in principle to the proposed development. However, because the development would result in a requirement to partially demolish the front of 146 Chaddesden Lane to allow for the associated means of access, the Committee objected to and recommended refusal of the proposal as it would have an adverse impact on the historic form of this locally listed building. It was noted that the location of the building on the back of the footpath was considered to be part of its historic importance.

#### **Spondon Conservation Area**

**Application No.** DER/07/11/00812 - Land at west side of 36 Sitwell Street (The

& Location: Homestead), Spondon, Derby, DE21 7FE

**Proposal:** Erection of 2 detached dwelling houses, detached garage, formation of

vehicular access and landscaping

The Committee recommended refusal of the application as it would impact severely on the Conservation Area. Members stated that the land concerned was historic garden space, part of the Homestead and its integrity should be retained. The Homestead is an important building, nothing should have an adverse affect on its setting, these houses would have an adverse impact on the setting of the grade I listed Homestead. Despite the fact that there was some present foliage separation and difference in level, the Committee urges that the wall be fully re-instated to its original height and design as the wall is also part of the historic fabric of the listed building.

The Committee raised no objection to the design but recommended refusal as Members felt that the proposed material was inappropriate in a Conservation Area. It was noted that wood frames were available with double glazed units.
