06/11 Remit of the Corporate Parenting Sub Commission

Members received the Corporate Parenting Sub Commission – Terms of Reference report.

There was some discussion around there being no formal role for Children and Young People Commission co-optees in the Corporate Parenting Sub Commission.

08/11 Children in Care Statistics Report

Members received a report from Andrew Bunyan, Strategic Director of Children and Young People, and Diane Grist, Deputy Head of Service (Children in Care).

The Strategic Director of Children and Young People reported that the number of children in care in Derby fluctuated between the high 480's and the low 470's. From 2005 there had been a gradual increase in the numbers of children in care. The rates of children in care was much higher than the national average. The distribution of placements across the UK showed that the vast majority are located in Derby. The Strategic Director of Children and Young People explained the reasons why children were sometimes placed outside the authority boundary. He said that there were higher numbers of young people in the upper cohort and he would look to reduce these numbers in the future.

Councillor Bolton noted that there were lots of babies at the lower end of the cohort. The Strategic Director of Children and Young People said that this was not surprising as Local Authority partners would have had concerns with those and so they come into care.

There was some discussion around the numbers of children who were in foster placements and care homes. Councillor Winter asked whether the 90 children in private/agency foster placements were in Derby. The Deputy Head of Service (Children in Care) reported that some may not be, but it was about finding the most appropriate support.

There was some discussion around the numbers of children in care of dual heritage. The Strategic Director of Children and Young People said that over the last five years there had been a significant increase in the numbers of young people entering the system of dual heritage.

The Deputy Head of Service (Children in Care) reported that care applications to courts are higher than they have ever been and that this is a national problem.

There was some discussion around the processes, timescales and approval rates of becoming a foster carer.

The Commission resolved to note the report

09/11 Children's Home Visits

Councillor Bolton reported that three Members had visited The Lighthouse on the previous day. It was recognised that children's home visits should be on the agenda for every Sub Commission meeting and that it was important to have feedback from Children and Young People officers after visits had taken place.

The Strategic Director of Children and Young People reported that there were two Ofsted reports each year about children's homes. It was agreed that the Sub Commission would want to see these.

There was some discussion around the content of the Members' Visit to Children's Care Home Report form. It was agreed to add Diversity to point 3. Health and Wellbeing so that a diversity breakdown could be recorded on future care home visits.

Resolved:

- 1. to note the procedure for Member visits to children's homes
- 2. that children's home visits should be on the agenda for every Sub Commission meeting and feedback be provided by an Children and Young People officers after a visit had taken place
- 3. to add Diversity to point 3. Health and Wellbeing on the Children's Care Home Report form
