

   given and tasked a student Social Worker to take this forward and
   develop a reviewed guide using the feedback from young people.
- In the design stages this will come back to the Our Voice, Our Success group for approval and amendments and OVOS will continue to have oversight and input



#### Tell us your thoughts on the proposals in the following areas

Residential Services – deletion of cook, reduction of use of taxis and agency staff, looking at the possibility of young people going to Foster Placements from Residential where possible

- Disagree some young people may not like change so removing the cook post may affect this. Especially for young people with Special Educational Needs and Disability
- Young people exiting residential should only be explored if it is appropriate for the young person and they are involved with any planned changes
- Need to keep the cook as young people may not have the same support if care staff will be helping to cook meals
- More funding may be needed for food hygiene if the cook post is deleted
- Young people exiting residential should only be explored if it is appropriate for the young person and they are involved with any planned changes
- Life skills could be gained if there isn't a cook as young people could help cook their own meals
- Agree with reducing taxis and agency staff

Fostering and Permanence – Freeze allowances for Foster Carers, Disband the exit from care team

- Disagree Foster carer could drop out if allowances are frozen meaning there could be less carers
- Disagree- Foster carers may struggle with the cost of living if allowances are frozen
- Disagree with disbanding exit from care team Social workers will have extra workload which may mean there isn't as much time for young people
- Disagree- Less foster carers could mean increasing costs for using private foster carers
- Disagree- It will put extra pressure on other teams if they disband the exit from care team

Libraries and Leisure – Less money spent on statutory libraries, end funding, staffing and book fund for community libraries, explore outside operator to deliver remaining leisure facilities Springwood and Derby Arena

- Disagree Libraries may have limited books/resources to use if you get rid of the others
- There should be one big library rather than numerous libraries
- Why are the other libraries not statutory? All the statutory libraries are close to the City Centre
- Disagree If they change the times then less people will be coming in which means they could shut down
- Agree things are more accessible online
- Libraries need to be accessible for everyone
- Improve the quality of the libraries that are already there
- Leisure centres don't want to lose accessibility such as memberships if they are run by outside business but they need to keep the community links



- A reversal of the proposal to freeze allowances for foster carers. Instead, they will rise by 2.3%.
- Continuation of the Exit from Care team in children's social care, so children and young people can continue to receive specialist support to help them stay with their families.
- Within Residential Homes, they retained the cook for our disabled children's home, young people in the homes are to complete food hygiene awareness and there are robust processes to support young people moving from Residential Homes should this be appropriate



- Work is still underway looking at outside organization to run the leisure centers'.
   Memberships would still be available and the organization would work with local communities.
- An additional investment of £186,000 for Community Managed Libraries in 2023/24, which sees the budget process adding £286,000 in total to ensure that funding is available to support the operation of the libraries as their management transfers to community and other interested groups
- Following approval of the Council's budget in February, initial work has started on putting the documents together that are required to start to the exploration of procuring an operator for the remaining leisure facilities.

# CiCC Regional Residential trip to Beaumanor Hall

What language is not felt appropriate by young people in care/what changes would you like to see?

- Do not like the term 'contact' and preferred the term 'family time'. However, others, including our Young Person disliked the term family time and preferred supervised contact.
- Do not like the term/role of Social Worker and feel it does not explain what they do and who they are.
- 'looked after child' many did not like this term and preferred 'child ' on its own like any other child.
- Do not like being referred to as children and there was some discussion as to when a 'child' becomes a 'Young Person'.
- Do not like the term 'Corporate Parent'
- Do not like the word 'placement ' as it did not feel like a home or a safe place
- Abbreviations being used by professionals like CP, CIN and LAC many of these words they do not understand and just sound negative and make them feel bad.
- Young People shared about conversations that staff have in their homes about their 'perfect lives' e.g. what fancy holidays they are going, what great family time they have had with their children and things they have brought them and how this made them feel



## Regional Residential

- The Participation Officer took this to Corporate Parenting Committee where it was recommended the language within Derby City Council changes
- The Director for Early Help and Social Care is committed to making these positive changes and is meeting with the Participation Officer to start this process

  - We picked a fish as the boy who is going to live in the house loves fishing.


## Small Children's Homes Interiors

- There is still a lot to do a request for help to paint murals on the walls has gone into our news letter





