What are NHS provider collaboratives?



Guidance released by NHS England in August 2021.

Provider collaboratives are partnership arrangements involving at least two trusts working at scale across multiple places, with a shared purpose and effective decision-making arrangements, to:

- reduce unwarranted variation and inequality in health outcomes, access to services and experience
- improve resilience by, for example, providing mutual aid
- ensure that specialisation and consolidation occur where this will provide better outcomes and value

Expectation that all acute and mental health Trusts would be in at least one collaborative by April 2021.

Community Trusts and ambulance services and non-NHS providers should be involved where this brings benefits for patients and systems

Benefits of provider collaboratives

Joined Up Care Derbyshire

- Deliver benefits of working at scale
- Create effective shared decision making structures
- Align providers within a shared purpose
- Reduce duplication and unwarranted variation
- Support resilience e.g. through mutual aid
- Joined up workforce planning
- Address health inequalities e.g. variation in access to services

Provider Collaborative Leadership Board Derbyshire

- Initially set up in 'shadow' form in 2021, now formally established within ICS architecture
- Meets quarterly with NHS provider Chairs
- Sets direction for the Provider Collaborative
- Maintains close working with the Integrated Place Executive
- Agreed maturity roadmap
- First year a developmental year
- Moving into delivery mode
- Programme Director in post

Joined Up Care Derbyshire

Purpose and function of JUCD collaborative

- develop partnership relationships, strengthening communication between providers and providing a forum for sharing approaches to challenges and opportunities
- develop and deliver collaborative approaches to specific challenges that are within providers' gift to resolve
- address efficiency, productivity and sustainability through collaborative working, integration or consolidation of service delivery or corporate functions
- reduce inequalities of access and unwarranted variation, where provider collaboration adds value
- take on some commissioning responsibilities within the ICS where this will align better with operational delivery and transformation, improve decision making and accelerate change



Interface with local authorities



- Integrated Care Strategy will set out the strategy for Derby and Derbyshire
- Provider Collaborative, along with Place, will lead on the delivery of strategy and transformation along with operational delivery
- Any significant service change proposals will require engagement with HWBs at an early stage
- Provider Collaborative will 'host' the Delivery Boards but recognises that this is system-wide, not just providers and there needs to be reporting into and engagement with Local Authorities and HWBs in fulfilling this function
- LA leads invited to join PCLB but felt that their involvement more appropriate via the Place meetings at this stage
