- 4.2 The Chair invited representatives from a range of providers in the city to give evidence. Members of the Adults Scrutiny Board undertook eight evidence gathering sessions from September 2021 to April 2022. They were able to question and receive further information on issues of concern. Notes of these discussions were taken.
- 4.3 The Board agreed to the recommendations contained within the report at its meeting of 19 April 2022 and delegated authority to the Chair to finalise the content of the report.

4.4 The Adults and Health Scrutiny Review Board approved the final report at its meeting on 5 July 2022. The Board resolved to share the report with Council Cabinet for their consideration. A minute extract from this meeting is attached at Appendix 1.
