1. Ref: 205001 – Jitty – Baker Street to Shardlow Road, Alvaston - received 12.01.05

Issue

Residents have requested the closure of the jitty between Baker Street and Shardlow Road.

Action reported at the meeting on 21 September 2005

June 2005 – It was reported that consultation had shown that a significant number of people still used the jitty and wished that it remains open. The Anti-social Behaviour Team visited this path and a few others in the Alvaston area and asked for more police patrols.

The Clean Neighbourhoods and Environment Act 2005 was passed shortly before the General Election. This legislation introduces the concept of 'gating orders', which will in the future allow the Council to introduce gates, to prevent problems in jitties such as this. When the regulations come into force the Council will introduce a process for identifying whether a gate is appropriate in any particular location. It was agreed that no action could be taken at this time.

September 2005 - Councillor Graves explained that many residents had been fighting for the closure of the jitty, and there had since been Anti Social Behaviour Orders placed. He informed the meeting that Council officers have stated that when the act is in force the closure of the jitty can be considered under the Clean Neighbourhoods and Environment Act 2005.

We are still waiting for information from the Department of Environment, Food and Rural Affairs - DEFRA about when the regulations to allow Local Authorities to make Gating Orders, as detailed in the Clean Neighbourhoods and Environment Act 2005, will come into force. The announced date for the regulations, according to Legal Services is Spring 2006.

2. Ref: 205012 – Markings around roundabout, Blue Peter, Shardlow Road, Alvaston – received 16.03.05

Issue

A member of the public indicated that there were inadequate line markings around the roundabout at the Blue Peter island.

Action reported at the meeting on 21 September 2005

June 2005 - A site visit was made to the junction to assess the carriageway markings at the approaches to the Blue Peter roundabout and the adjacent one at the junction with Raynesway. The carriageway is currently marked with arrows that indicate which lane to be in for the direction you are travelling; these marking haven't been altered since the opening of the A6 Alvaston Bypass, but do not give a misleading message to drivers. It should also be noted that these markings do not have any legal standing, they are purely advisory.

The most effective way of correctly and safely directing drivers at busy junctions, particularly roundabouts is a comprehensive system of direction signs. All the direction signing in this area and Shardlow Road is currently being reviewed following the opening of the bypass and the imminent reclassification of Shardlow Road. The existing signing is not to current standards and since the opening of the A6 Alvaston Bypass, many of the destinations currently signed in the area of the District centre are now unnecessary as the bypass represents a more suitable route. The new signing scheme will provide a much clearer message to drivers and remove unnecessary street clutter, thereby creating a more pleasing environment.

Area Panel may also be interested to learn of the proposed introduction of a 7.5 tonne weight limit on Shardlow Road, this restriction will prevent goods vehicles from using roads in the area unless they are gaining access to premises.

September 2005 - We are currently working on changing the signing now that the Shardlow Road has been reclassified. The signing will direct traffic left at Harvey Road towards the Alvaston by-pass.

Issue

Ann Garfield asked that because recent legislation had been introduced that allowed Councils to introduce Gating Orders, could residents resubmit petitions requesting the closure of jitties such as the one from Beech Avenue to Raynesway.

7. Ref: 205017 – Petition – Installation of pedestrian crossing on London Road – Burnaby Street/Meadow Lane, Alvaston – received 15.06.05

Issue

On 4 February 2005, a petition signed by 216 people was received requesting the provision of a pedestrian crossing on London Road near its junction with Burnaby Street and Meadow Lane.

Action reported at the meeting on 21 September 2005

June 2005 - A full report was available at the meeting which suggested that the request be refused, as the investigations that were carried out indicated that the threshold for the installation of a pedestrian crossing facility was not met at this location. Dave Taylor, Alvaston resident confirmed that 369 people had now signed the petition, and agreed with the Councillors that something is desperately needed, and asked that the panel rejects the officers proposals.

The area panel accepted the report recommendations to refuse a pedestrian crossing however they asked the Director of Development and Cultural Services to consider installing a refuge in next years budget. They also asked for the cost of installing the refuge to see if the area panel could fund it through their budget.

September 2005 – It was reported that Highway officers have surveyed the site for a refuge and they confirmed that there is enough room for a refuge at the location. The approximate cost to install the refuge would be £5,700. The Area Panel was asked to consider funding this from their budget allocation in 2005/6.

9. Ref: 205033 – Twin bins, Alvaston – received 21.09.05

Issue

An Alvaston resident explained that the twin bin scheme had been introduced in her area, and she now has three bins. She raised concern over the requirement for residents to wash their recycling items before collection, as she did not feel that this should be the public's responsibility. She asked the panel how much both the blue and brown bins were costing the tax payers. She also asked who would pay for the cleaning of the bins, and whether local sites would be removed.

She reported that the calendar is also very difficult to understand for the older residents.

Councillor Wynn stated that the Council Cabinet agreed that they need to have an urgent review of the implementation of twin bin schemes in areas of terraced houses and inner city, as it is clear that there are associated problems, with leaving bins out on the pavements, lack of storage and the assumption that it is a good thing to do everywhere in the city.

Updates on agreed actions to feedback to the meeting on 9 November 2005

A response has been sent to the resident. The cost of providing a refuse collection service is approximately £74.62 for each household in Derby. The majority of this cost is the disposal of the rubbish.

The Council does not provide a wheeled bin cleaning service for any bins; these services are all provided by private companies and are used by people who wish to keep their bins clean. We do not endorse this practice and often have problems with waste being left on the street.

There are no plans to remove local recycling sites. Many sites have seen increased usage since the scheme started while we have been able to reduce the number of banks on other sites. Different people like recycling in different ways so we provide the opportunity for people to choose which method to use.

The calendar has proved very successful. We produce a large print version, a black and white version, a tape version or make home visits to talk through the scheme. If you know someone who has difficulty understanding the calendar please ask them to contact 715000 for help and advice.

Issue

A resident asked the panel how long the temporary bus lane would be in use for, as she had seen three serious accidents since its installation due to the road not being wide enough.

Action reported at the meeting on 21 September 2005

New item.

Public response at the meeting on 21 September 2005

Council response at the meeting on 21 September 2005

Councillor Tittley confirmed that he had put in an official objection to this bus lane to Michael Foote. David Gartside explained that the bus lane is an experimental order that could last for 18 months. The Council were monitoring the affects of the bus lane on a regular basis and the results of the monitoring will determine whether it stays in as a permanent measure.

He explained that the Council were trying to change people's behaviour and make buses more attractive than using their own cars. The conflict here was that some people were using the bus lane dangerously while others were not, and this was causing the problem. If a bus lane was well respected buses could gain an advantage on their journey into the city. The way the traffic signals worked on the roundabout the bus lane should not cause an issue for other traffic. The idea was that the more people that use the bus, the less cars there would be on the road, which would result in less traffic.

Councillor Liversedge commented that the bus lane did not help, and the timing of the traffic lights were also a problem and that they should be removed.

Councillor Blanksby agreed with David Gartside, and stated that to overcome the vast volume of traffic there needs to be radical solutions. Different ideas had to be trailed to make public transport more attractive so people will be more willing to leave their cars at home, and use the bus.

Councillor Wynn said it was likely the bus lane would cause inconvenience to car drivers and added that the solution was not to remove the traffic lights. He stressed that the payback on these changes is long term, and there is an urgent need to promote public transport. He acknowledged that installing bus lanes is a painful process, but by changing behaviours now, will benefit the next generation. He also stressed that accessibility needs to be looked at, and investment needs to be made upfront into public services.

Councillor Tittley proposed the removal of the bus lane to be referred to Cabinet. Agreed to recommend Council Cabinet remove the bus lane in Allenton.

Councillor Wynn explained that he is a Private Finance Initiative - PFI board chair, and confirmed that the PFI scheme includes proposals for that site. He stated that it does however need the agreement of all the partners, and therefore does not just rest with the School Governors.

The Upper School site of Merrill College - both land and buildings - will be disposed of when the new single school on Upper Moor Road is completed and ready for occupation – currently set for September 2006.

The land and buildings are owned by the Governing Body, having transferred from ownership by the Council when Merrill became a Grant Maintained - now Foundation school.

Although owned by the Governing Body, discussions have already started between the Council and the governors concerning a 'partnership approach' to the disposal process, which although beginning around September 2006, is likely to take several months to complete before a sale on the open market can be effected.

At this stage, it is not possible to determine how and when re-development of the site will take place, but such re-development will be subject to the appropriate planning conditions and guidelines, including arrangements and opportunities for local residents to express their views concerning the planning applications received.

14. Ref: 205035 – Vandalism, Field Lane Community Centre, Boulton – received 21.09.05

Issue

A member of the public asked the panel if it was a high priority that a long term solution is found to the ongoing vandalism of the Community Centre. He stated that serious vandalism as led to the closure of the facilities.

Action reported at the meeting on 21 September 2005

Council response at the meeting on 21 September 2005

Councillor Jackson confirmed that in May the facility was badly vandalised, and was closed down. A meeting had taken place with the Leader of the Council and other senior officers. She stated that repairs would cost about £80,000. A list of key items to engage the public had been drafted. The Council are committed to keeping the facility open, as there is a lack of facilities in the area, but it needs to be sustainable so that vandalism does not pose a future problem.

Councillor Blanksby confirmed that a 17 point plan was drawn up after this meeting - one of the vital elements in getting it open is the confidence of the community centre users, and the community at large. Without their support and help, it won't survive. Councillor Jackson started that discussions have been held with users of the centre and they support proposals to reopen it. They are committing their groups to continue to use the centre. Police and youth service support keeping it open.

Councillor Leeming agreed that this has been plagued by vandals and drug addicts. He reported that in May this year, the Council were doing repairs on the building, including an high security fence. Have it on record that when the fence was erected, there was a marked drop in vandalism. Unfortunately when the Council did repairs to a building to the side of it, when the scaffolding was erected, it was not, as legally required, made so people could not climb up it. This resulted in vandals damaging the roof.

The centre is currently closed. Councillors and officers met on 14 September to discuss the situation and the impact of the closure on centre users and the football teams. The preference would be to repair and reopen the centre as soon as possible if funding can be found. A survey has been carried out to determine the cost of repairs.

The Asset Management Group approved funding of £4,000 for measures to reduce vandalism and overnight security patrols are now being carried out. The Youth Offending Service and Youth Service are working in the area to try and reduce vandalism. Further damage has recently been caused to the building. The situation will be monitored prior to a final decision on the future viability of the centre and its priority for funding being made.

Mrs Nixon spoke on behalf of a resident in Newbridge Crescent, who understood that the tree at the back of the property could be pruned. This has not yet been done, and is blocking light from the house.

The Arboricultural Officer has investigated the tree which is actually in Hubert Shaw Close. He has spoken to the resident about the tree and explained that unfortunately the work that the resident feels is required would not be acceptable working practice for this tree. Heavily pruning the tree would not be good for the health and safety of the tree. It is likely to lead to weak branch unions and the possibility of allowing decay to further weaken such unions, other pruning that may have been acceptable such as crown lifting or thinning has already been carried out.

The tree is in the garden of a Derby Homes tenant and not on open space and is therefore in the first instance the responsibility of the tenant.

Therefore there is unfortunately no acceptable pruning that is likely to bring about an appreciable difference to the shade cast by the tree.

Public response at the meeting on 21 September 2005

The resident stated her dissatisfaction at the response, stating that the resident on Hubert Shaw Close is now very ill.

Council response at the meeting on 21 September 2005

Councillor Tittley agreed that this was an unsatisfactory response, and agreed that something needed to be done as a matter of urgency, which would need to include the review of the tree policy.

Councillor Willetts questioned why the tree could not be cut down. He felt that the council should do something about it if this is having such an effect on a resident.

Councillor Wynn explained that this issue had been ongoing for 18 months, and they had been assured that the tree policy would be reviewed. He confirmed that the new policy was now in draft format, and the new Cabinet had looked at this, and raised two issues that were lacking. Criteria – which would include lack of light, potential structural damage, and the second issue looked at resources. The tree resources are inadequate, and there is a recognition that more resources are needed along with the objective criteria. These two issues would be considered in the future.

A full report to the petition was presented to the area panel on 15 June 2005. It was reported that the proposal is not in line with Council Policy regarding loss of public open space. The following course of action was proposed as a means to testing and resolving this particular proposal:

- The petitioners should submit a planning application for the proposed fence and change of use. The application should be clear in demonstrating community support and benefit for the proposals
- 2. The application will be dealt with as part of the normal planning process. As part of this Parks will be consulted and will make an objection on the grounds of loss of public open space and this being against Council policy. Other objections may also be received from other organisations and/or individuals
- 3. The application will be reported to the Planning Committee for a decision
- 4. If a fence is chosen that requires planning permission then this will also be decided as part of the approval process. If a fence is selected that does not require planning permission then details of the fence should be submitted to the Council for approval as landowner and to ensure the fence does not impact on the amenity of the park.

It was recommended that the applicant select a dark green or black weldmesh style fence, preferably no higher than 2 metres. The applicant would also need to provide a minimum 400mm wide mowing strip under the fence to the satisfaction of the Parks Section. If planning approval is granted then Estates will prepare the necessary lease documents, including details of maintenance standards and future use of the land. The land would be transferred to Education and the area enclosed would no longer be public open space

September 2005 - Andy Morgan, Landscape and Development Officer, met with the Association and Councillor Tittley in July. It was confirmed what type of fencing Parks would approve and examples were sent to the Councillor and Association. Fencing less than 2 metres high, in this location, will not need planning permission, however the Community Association will still need to resubmit their planning application because of the change of use proposed.

On submission of a new application Parks and others will have the opportunity to comment on the proposed change in use of the public open space.
