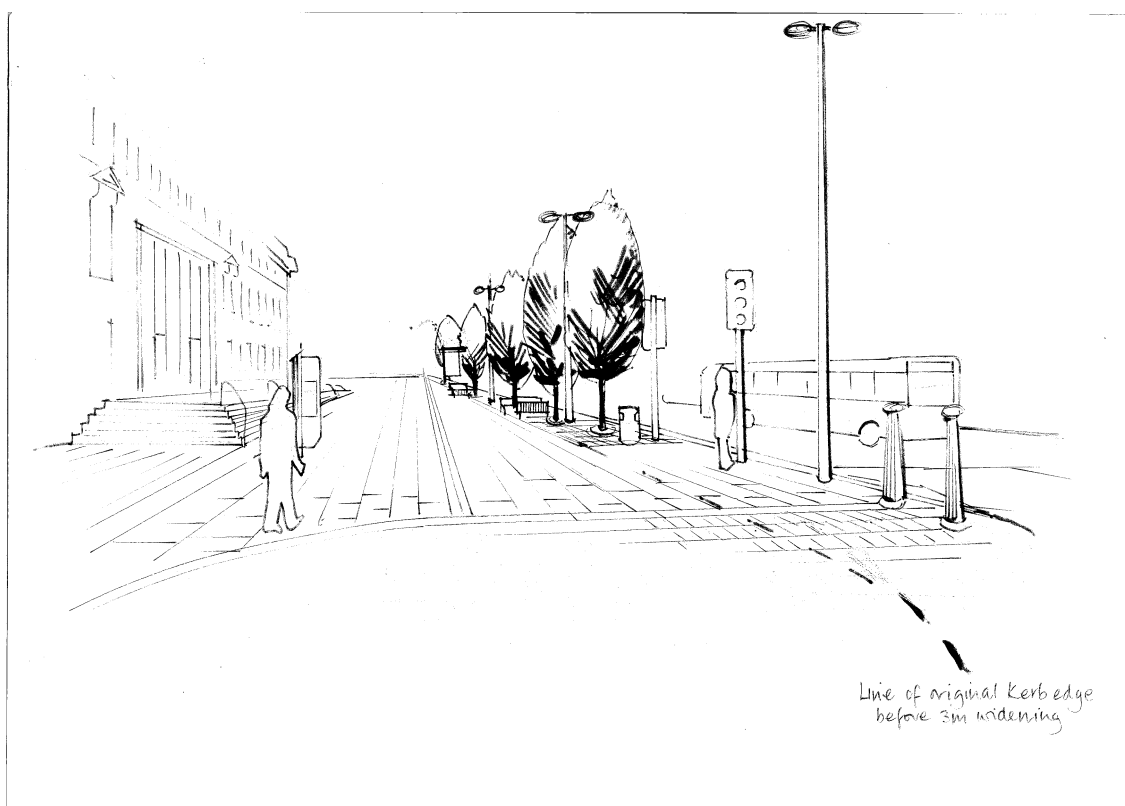


Corporation Street Improvements

SUMMARY

- 1.1 Improvements to Corporation Street is being taken forward as part of the Council's Public Realm programme, to revitalise the setting of the Council House and knit together the Hydro, Riverlights, Riverside Gardens & Council House projects.
- 1.2 A key part of the project is to rationalise street furniture and a sketch scheme has been completed using the public realm pallet (Yorkstone, granite etc). In order to provide a sense of enclosure to the street at the carriageway and to allow an uncluttered frontage to the step/ramp area, a main zone of street furniture is shown as below (but now amended to widen only 1.5m and allow the same on the other side of the street where queuing for buses requires more space):



- 1.3 One of the design judgements is to remove the large cctv column from just outside the front entrance of the Council House, and relocate to a wall mounted position on the

Assembly Rooms. This would still give the required level of coverage in the area, but minimise the number of columns. See the two photos in the appendices.

RECOMMENDATION

- 2.1 To note the contents of the report and give advice on the proposals for moving the cctv to a wall mounted position on the Assembly Rooms, as an enhancement to the overall rationale of street furniture in this part of the city centre conservation area.

REASONS FOR RECOMMENDATION

- 3.1 To ensure that Conservation Area Advisory Committee are kept informed of proposals and have influence over the judgements on wall mounted cctv.

OTHER OPTIONS CONSIDERED

- 5.1 No other options have been considered. Whilst in some areas, cctv is not now felt to be useful, it is deemed important to retain some coverage in Corporation Street, along Full Street and Derwent Street.
