Derby and Derbyshire Waste Local Plan Revised Deposit Edition

RECOMMENDATION

- 1.1 Subject to any views expressed by either the Prosperity and Planning or the Environment and Sustainability Overview and Scrutiny Commissions, to approve the following recommendations of the Derbyshire Development Plans Joint Advisory Committee which met on 17 April 2003:
 - a. to approve the recommendations set out in the appended Report of Publicity and Consultation and the consequential proposed changes to the Plan, subject to any necessary minor editorial changes
 - b. to authorise the undertaking of the necessary formal procedures for the next stage of plan preparation, including the publication of the Revised Deposit of the Derby and Derbyshire Waste Local Plan.
- 1.2 To seek the views of the Prosperity and Planning and Environment and Sustainability Overview and Scrutiny Commissions on this report.
- 1.3 If the Commissions express views on the report, to reconsider these recommendations in the light of any view expressed by the Commissions, at the next suitable meeting of the Cabinet.

SUPPORTING INFORMATION

- 2.1 In March 2002 Cabinet Members from the City and County Councils approved the First Deposit of the Joint Waste Local Plan. Consultation on this document took place in June 2002. Members must now consider the representations received in response to consultation and any changes needed to address issues raised.
- 2.2 On 17 April 2003 the Derbyshire Development Plans Joint Advisory Committee (JAC), considered:
 - a. the results of the consultation on the Plan, and
 - b. a proposed Revised Deposit Waste Local Plan. They recommended that the revised Plan and its associated documents be approved for publication.

- 2.3 Appendix 2 reproduces the covering report to JAC which summarised the major issues raised as a result of the consultation on the First Deposit Edition, and the main changes proposed from the First to the Revised Deposit Edition of the Plan. Annex 1 to the JAC report is also reproduced. This contains the Report of Publicity and Consultations and Schedule of Proposed Changes. The Revised Deposit version of the Plan and the Environmental and Sustainable Development Appraisal, which formed Annexes 2 and 3 to the JAC report can be viewed on Derbynet at:
