Joined Up Care Derbyshire Update

Purpose

1.1 This report provides an update from Joined Up Care Derbyshire (JUCD).

Recommendation

2.1 To note the update from JUCD.

Reason

3.1 To ensure that the Health and Wellbeing Board is informed of, and engaged with, JUCD, ensuring alignment and joint effort as necessary on shared priorities.

Supporting information

- 4.1 Integrated care systems (ICSs) are partnerships of organisations that come together to plan and deliver joined up health and care services. Each ICS comprises of:
 - Integrated Care Partnership (ICP) the broad alliance of organisations and representatives concerned with improving the care, health and wellbeing of the population, jointly convened by local authorities and the NHS.
 - Integrated Care Board (ICB) bringing the NHS together locally to improve population health and care.
- 4.2 Joined Up Care Derbyshire (JUCD) is responsible for coordinating health and social care across Derby and Derbyshire. It is one of 42 Integrated Care Systems across England, and brings together NHS bodies, local authorities and voluntary sector organisations to deliver better care for our whole community.
- 4.3 Derby and Derbyshire ICP continues to operate in shadow form. Work is ongoing to formally establish joint arrangements between Derby and Derbyshire ICB, Derby City Council and Derbyshire County Council. As part of due process, reports will be taken to the Cabinets of both Councils in the autumn.

- 4.4 Over summer, JUCD has had a focus on recruitment and career development to develop our local workforce. This has included:
 - Two large health and social care recruitment events in June. JUCD along with nearly 30 employers across health and social care in Derby and Derbyshire participated at the events at Chesterfield and Derby Colleges.
 - Levy gifting to fund over 40 apprenticeships across a range of roles in the system.
 - A Sector Work-based Academy Programme (SWAP) to be held in September 2022 aimed at people who are currently unemployed and are looking to get into the social care sector.
 - Re-introduction of virtual work experience programme with Springpod[®]. The
 programme features modules on various careers such as care work, midwifery,
 allied health professions, administrative and non-clinical roles.
 - Further development of the Step Into Work programme including collaboration
 with The Prince's Trust and the development of an 'enhanced' model for the
 programme to improve access for candidates who are otherwise excluded from
 entry to vocational training.

- 4.5 JUCD has introduced regular Team Derbyshire Briefings for all health and care colleagues working in Derby and Derbyshire. Sessions look at different aspects of the health and care system to help grow our understanding of what it means to be an Integrated Care System.
