Location: Darley Abbey, Little Chester, Chester Green, North Riverside, Bass Rec', Pride Park to Alvaston Park, Derby

Proposal: Outline application with full details of 'Package 1' for flood defence works along the river corridor involving; demolition of existing buildings, boundary treatments and flood defence walls, removal of existing flood embankments, vegetation and trees, the raising, strengthening, realigning and construction of new flood defence walls, embankments, access ramps and steps, demountable flood defences and flood gates, the construction of replacement buildings, structures and community facilities, alterations to road, footpath and cycleway layouts along with associated and ancillary operational development in the form of ground works, archaeological investigation works and landscaping works to reinstate sites with environmental enhancements included.

Resolved to recommend refusal on the following grounds:

- 1) the proposal is harmful and detracts from the character and appearance of the conservation area**
- 2) The application included an internally illuminated sign**
- 3) Many elements of this proposal are contrary to the Derby City Council shop front and advertisement guide. It was suggested that elements of the original shopfront might be underneath the existing fascia, that reinstatement of a traditional shop front would be beneficial as would the reduction in the depth of the fascia, the division of the fascia into three with the addition of pilasters. There was also not enough information on the proposed canopy or the materials including the visual appearance and way in which the tiles would work.**

- 2) the Committee strongly regretted that work had commenced without prior authorisation**
- 3) The Committee suggested that in relation to the removal of the window and installation of vent that a justification is submitted as to why the window needs to be removed, whether it could be adapted to accommodate a vent.**
