# **Cummings Street Car Park**

Investigation, Consultation Results, Conclusions and Recommendations



#### **Project Brief**

The project brief was provided by the Transportation Group in conjunction with the Normanton Neighbourhood Manager. Essentially it consisted of the following requirements.

- Investigate the feasibility of improving access to the car park on Cummings Street, by opening its junction with Lowerdale Road
- Report on identified issues and costing for potential options for solutions

This report has been brought together through a combination of site observations, local knowledge, historic and anecdotal information and consultation with local people.

#### **Background**

Cummings Street car park was created a number of years ago to provide a small amount of parking for people visiting the nearby shops around the southern end of Normanton Road. There is no charge to use this car park.

Subsequently, in an attempt to control inappropriate through traffic, the junction of Cummings Street and Lowerdale Road was closed off and access to this car park was now via Lyndhurst Street. (See plan appendix one)

### Investigations/observations

The concerns expressed were that a large amount of irregular and illegal parking goes on by people who are visiting the shops in the vicinity. This leads to congestion and road safety issues for pedestrians, cyclists and drivers.

This car park is underused by shoppers and is used more by residents of Cummings Street. This is likely to be because of the protracted access and egress arrangements. Other car parks in the area such as the private one owned by Pak Foods and the public one off of Pear Tree Road were, however, very well used. In fact the public car park off Pear Tree Road appears to suffer from long stay abuse which only serves to exacerbate the situation.

There is anecdotal evidence that the area close to the junction in question suffers from a high level of anti-social behaviour, of various type which deters people from leaving vehicles in the car park.

#### **Proposed Options**

Historically the junction of Lowerdale Road and Cummings Street was closed as a method of addressing a "rat running" problem that existed. Vehicles

found it a convenient way of avoiding the queues on Normanton Road. It was important that the options put forward did not encourage this inappropriate through traffic to return.

Lyndhurst Street is currently a one way, away from Normanton Road and Chestnut Avenue is one way towards Normanton Road. This in itself helps to reduce through traffic if the junction is re-opened.

Options one, two and three are essentially very similar in nature, however options one and two seek to completely remove through traffic by making Cummings Street two-way from Lowerdale Road to the Car Park and then one way beyond. Option three allows two-way traffic over the entire length of Cummings Street. Option four was simply to do nothing.

Option two gives the least advantage to through traffic and also provides the least amount of deviation required by residents of Cummings Street.

Another consideration to bear in mind is that options, one, two and three will all require the removal of the three trees at the junction of Lowerdale Road and Cummings Street and the relocation of some street furniture.

#### Consultation

A consultation leaflet was distributed to local ward members and to every property on Cummings Street, Lyndhurst Street and Chestnut Avenue as these residents would be the most affected by the proposals. Residents were given the opportunity to comment on the four options. A copy of the leaflet is attached to this report as appendix two.

In total 125 leaflets were delivered by hand and marked to allow a detailed analysis from each of the three streets.

Of the 26 leaflets that were returned the following results were obtained:



#### Conclusion/Recommendation


As can be seen from the results of the consultation there is a very even split between option one and option four. After consideration of all the factors involved here it is felt that, whilst opening up the junction with Lowerdale Road would encourage a slight increase in use of the car park it would not generate sufficient usage to make any appreciable difference to parking problems around the area. It is the view of the author that, as the public opinion is so evenly divided; there is no clear mandate to implement option one and therefore in this instance option four, to do nothing, is the recommended course of action.


## Appendix one
