# Honorary Freedom of the City

# Purpose

- 1.1 The Honorary Freedom of the City of Derby is the most prestigious honour that can be bestowed upon an unelected person by the Council. Local authorities across the United Kingdom can grant this honour to persons of distinction who have rendered eminent services to their local areas.
- 1.2 Council has previously agreed to summon Extraordinary Meetings so that Honorary Freedom of the City may be granted to Mr Wayne Rooney, Ms Sandy Ryan and the Rt. Hon. Dame Margaret Beckett MP.
- 1.3 This report sets out the legislative basis upon which awards for Honorary Freedom must be made. It is for the Full Council to determine whether they wish to proceed with conferring Honorary Freedom to the three individuals previously nominated.

#### Recommendations

- 2.1 To determine whether Council wishes to pass the following resolutions, under powers vested upon the authority under Section 249 of the Local Government Act 1972:
  - 1. Council resolves to confer on Mr Wayne Rooney the Honorary Freedom of the City of Derby
  - 2. Council resolves to confer on Ms Sandy Ryan the Honorary Freedom of the City of Derby
  - 3. Council resolves to confer on the Rt. Hon. Dame Margaret Beckett MP the Honorary Freedom of the City of Derby.
- 2.2 To note that contact will be made with recipients of the awards for a civic reception to be arranged, when they will receive the honour from the Mayor of Derby.

#### Reasons

3.1 Under Section 249 of the Local Government Act 1972, Honorary Freedom of the City must be granted at an Extraordinary Meeting of Council specially convened for the purpose.

# Supporting information

- 4.1 To bestow the status of Honorary Freeman of the City on any person, Council has to be satisfied that they are a person of distinction or a person who has, in Council's opinion, given eminent services to the city.
- 4.2 The Council has previously used its powers under the 1972 Act to grant Honorary Freedom of the City to three other individuals:
  - Football manager Brian Clough, to mark his success in transforming Derby County from a Second Division team into English League Champions in 1972 and European contenders thereafter;
  - Swimmer Adam Peaty, following his multiple successes at the Commonwealth Games, European and World Championships, culminating in his Gold Medal-winning performance at the 2016 Rio Olympic Games.
  - Footballer Reg Harrison, who was the last surviving member of Derby County's FA Cup winning team of 1946 and who subsequently worked as part of the Council's Youth Service, establishing several youth centres and junior football clubs across Derby.

# Wayne Rooney

- 4.3 At its meeting of 25 May 2022, Council resolved to award Honorary Freedom of the City of Derby to football manager, Wayne Rooney. Minute extract 21/22 is attached at Appendix 1.
- 4.4 During an unprecedented footballing career, Mr Rooney became the record goal scorer for both Manchester United and the England national team. In August 2019, he joined Derby County as a player-coach before being appointed as permanent manager of the club in January 2021 and retiring as an active player. Under Mr Rooney's leadership, Derby County narrowly avoided relegation on the last day of the 2020-21 season.
- 4.5 Preparation for the following season was thrown into disarray by the possibility of English Football League (EFL) sanctions regarding breaches of financial fair play regulations and the imposition of a transfer embargo. In September 2021, it was announced that Derby County would be placed into administration and incur an automatic 12-point deduction. Further points penalties were applied by the EFL later in the season. Protracted negotiations followed with several parties interested in purchasing the club out of administration. Despite battling performances on the pitch, Derby County were relegated to League One in April 2022, seven points from safety.
- 4.6 Mr Rooney was recognised by the Council for his commitment to the club and its fans during this turbulent period. In June 2022, he resigned his position shortly before the club was purchased out of administration by local businessman David Clowes. Following a period managing in the United States, Mr Rooney was recently appointed as the manager of Birmingham City.

# Sandy Ryan

4.7 At its meeting of 24 May 2023, Council resolved to award Honorary Freedom of the City of Derby to boxer, Sandy Ryan. Minute extract 20/23 is attached at Appendix 1.

- 4.8 Ms Ryan is the current World Boxing Organisation (WBO) Women's Welterweight Champion, having won the title via a unanimous points decision in April 2023. In her seven professional bouts to date, she has won six. Before turning professional, Ms Ryan was a Commonwealth Games gold medallist at welterweight and a World Championship silver medallist at light-welterweight.
- 4.9 Born in Derby in 1993, Ms Ryan proudly represents the city and speaks publicly about her strong sense of local identity. The Council previously recognised her discipline, perseverance and good sportsmanship.

#### Dame Margaret Beckett

- 4.10 At its meeting of 19 July 2023, Council resolved to award Honorary Freedom of the City to politician, Dame Margaret Beckett MP. Minute extract 33/23 is attached at Appendix 1.
- 4.11 Dame Margaret has served as the Member of Parliament for Derby South since 1983, having previously been elected as the MP for Lincoln between 1974 and 1979. During her lengthy Parliamentary career, Dame Margaret has served as a minister in four Labour Governments.
- 4.12 In 1976, Dame Margaret was appointed to her first ministerial role, serving as Parliamentary Under Secretary of State at the Department of Education and Science under Harold Wilson's premiership. In 1984, Dame Margaret was appointed as Shadow Chief Secretary to the Treasury. Following the 1992 general election, she was elected as Deputy Leader of the Labour Party and served as Shadow Leader of the House of Commons. After the sudden death of John Smith in May 1994, Dame Margaret became Acting Leader of the Labour Party and would later contest the party leadership against Tony Blair and John Prescott.
- 4.13 Following the 1997 General Election, Dame Margaret would hold several senior positions in Tony Blair's government. Between 2001 and 2006 she would serve as Secretary of State for Environment, Food and Rural Affairs, before being appointed as Foreign Secretary in 2006, becoming the first woman to hold the role and only the second to occupy one of the four great offices of state.
- 4.14 Since leaving Government, Dame Margaret has continued to be a prominent voice within the Labour Party and has occupied various public roles. In 1993 she was appointed to the Privy Council and in the 2013 New Year Honours made a Dame Commander of the Order of the British Empire.
- 4.15 During her tenure, Dame Margaret was regularly seen attending events and hosting advice surgeries in Derby, often alongside her late husband Leo Beckett. Having graduated with a degree in metallurgy and taken up her first role within the Labour Party as a researcher in industrial policy, Dame Margaret has regularly championed the city's transport engineering industry. She has stated her intention to stand down from Parliament at the next General Election.

# **Debate and Determination**

- 4.16 The normal rules of debate will apply when considering the draft motions detailed at recommendation 2.1, together with any amendments that may be proposed. It is recommended that they are moved and debated separately.
- 4.17 A two-thirds majority of voting councillors is required to pass a resolution to award Honorary Freedom of the City. The table below details the number of votes required for the motions to be carried:
