### 1) *Rewiring Public Services*

It was moved by Councillor Bayliss and seconded that

‘Derby City Council welcomes the LGA initiative ‘Rewiring Public Services’ and resolves to support the general thrust of the proposals set out in their programme of 10 Big Ideas.

We believe the re-energising of local authorities is long overdue, following the centralisation of services by successive governments, resulting in councils being unable to adequately provide local services, particularly in the current climate of austerity.

This Council believes that the pursuit of these aims and objectives would significantly enhance the call for a fair deal for Derby that is the current policy of the Council.’

It was moved by Councillor Carr and seconded that the motion be amended by the deletion of the third paragraph

The amendment was carried

**Resolved that**

**‘Derby City Council welcomes the LGA initiative ‘Rewiring Public Services’ and resolves to support the general thrust of the proposals set out in their programme of 10 Big Ideas.**

**We believe the re-energising of local authorities is long overdue, following the centralisation of services by successive governments, resulting in councils being unable to adequately provide local services, particularly in the current climate of austerity.’**

2) *Education in Derby*

**Resolved on the motion of Councillor Rawson and seconded that**

**‘Council notes the article published in the Derby Telegraph on 20 November with the headline: ‘Get your facts straight Mr Gove!’**

**Council is pleased to recognise that 72 per cent of schools in Derby have been rated either ‘outstanding’ or ‘good’ by OFSTED, compared to just 50 per cent in June 2012. It is noted that Derby’s schools are improving more quickly than the national average. This Council recognises with appreciation the hard work of headteachers, teachers, students and local authority improvement partners, in raising standards and levels of attainment.**

**Council also rejects the erroneous comments, based on outdated information, made by the Secretary of State for Education, Michael Gove, in response to questioning in the House of Commons from the Member of Parliament for Derby North, Chris Williamson.**

**This Council therefore agrees to oppose Michael Gove’s ideological policies which are damaging the education system. Despite the increasing prevalence of academies and free schools, Derby City Council recognises its responsibility to intervene where necessary to meet the educational needs of all of Derby’s children and young people whatever the legal status of their school.**

**Council therefore calls upon the Coalition Government to ensure all local authorities have the powers and resources needed to deliver high levels of educational attainment at all establishments in their area, including free schools, and to guarantee that there is no repeat of the Al-Madinah scandal here or elsewhere.’**

3) *Cost of Living Crisis*

**Resolved on the motion of Councillor Russell and seconded that**

**‘Council recognises we are in the midst of a cost of living crisis.**

**Council notes that prices continue to rise faster than wages for residents in Derby and beyond. Council also recognises that working people are on average £1,600 worse off today than they were in 2010.**

**Council calls on the Government to ease this burden. Council supports the introduction of the living wage nationally, a freeze on energy prices and the abolition of the bedroom tax.**

**Council notes that the administration is tackling the cost of living in Derby, despite the intransigence of central government.**

**Council endorses the introduction of further policies that support working people through the cost of living crisis and will lobby the Government to stand up for the interests of working people, rather than the privileged few.'**

4) *Conduct of Councillors*

It was moved by Councillor Higginbottom and seconded that

'This Council agrees that its collective role is to work on behalf of the citizens of Derby to achieve the best results for the city. Council recognises the importance of behaving in a business-like manner and the way to ensure this is to introduce a zero-tolerance of bickering and personal attack within the chamber.'

It was moved by Councillor Hickson and seconded that the motion be amended, by removal of the section

and its replacement with
