## 08/15 SACRE Membership, Resignations and Vacancies

The Clerk to the SACRE updated Members on the SACRE's membership and vacancies. The Clerk called on all Members to assist in filling the vacancies. It was agreed that the Clerk would email a list of current vacancies to all Members.

Members noted that Quazi Abdul Mateen had now been formally nominated as an Islamic Faith representative in Group A.

Centre and introduced Sam Mitchell, the new manager of The Open Centre, to be Co-opted in her place. Members agreed that Sam Mitchell be Co-opted to the SACRE. Members wished their appreciation of Laura Connelly's work with the SACRE to be noted.

Members expressed their concerns that RE was not included in the English Baccalaureate. It was agreed that the Lead Officer would draft a letter to the Department for Education, expressing the SACRE's concerns.

- 2. to agree that the Lead Officer to the SACRE should draft a letter to the Department for Education, expressing the SACRE's concerns that Religious Education was not included in the English Baccalaureate.**

## **10/15      National Updates**

The Lead Officer to the SACRE updated Members on Ofsted inspections and the requirement of schools to promote the spiritual, moral, social and cultural development of their pupils. Members also considered how this related to the Prevent strategy.

## **11/15      Learning to Live Together Conference and Guidance on Values and Equalities**

The Lead Officer to the SACRE updated Members on the Learning to Live Together Conference. It was reported that the conference had taken place in June 2015 and had been well attended.

Members discussed whether the conference papers should be distributed to schools.

It was agreed that the documents be circulated to schools.

Members discussed the Prevent strategy in relation to ensuring that young people were protected and safe. Members agreed that Derby City Council's Prevent Lead should be invited to a future meeting of the SACRE to speak on Religious Education's contribution to the Prevent strategy.

- 2. to agree that the conference papers be circulated to schools; and**
- 3. to invite Derby City Council's Prevent Lead to a future meeting of the SACRE to speak on Religious Education's contribution to the Prevent strategy.**

## **12/15      School Visits**

The Senior School Improvement Officer noted that the SACRE had previously undertaken a number of school visits and asked Members whether they would like to re-state their interest in visiting schools. Members agreed that it would be good to revive school visits. It was agreed that the Senior School Improvement Officer should explore the possibility.

It was also suggested that Derby City schools could be invited to attend future meetings of the SACRE, to give presentations on Religious Education school projects.

**Resolved to agree that the Senior School Improvement Officer explores the possibility of SACRE school visits being commenced again.**

## **13/15      Relationship with NASACRE**

The Lead Officer to the SACRE spoke to Members on the SACRE's relationship with NASACRE. Members agreed that the Chair of NASACRE should be invited to speak to the SACRE on the national picture and the impact that local SACREs had. It was agreed that The Lead Officer to the SACRE should pursue the possibility of a joint event with Derbyshire SACRE.
