# Council Tax Support Scheme Consultation 2018 Consultation Plan

### **Purpose of the Consultation**

We are proposing a change to our Council Tax Support Scheme so that from 1 April 2019 the time limit that Council Tax Support claims can be backdated for is increased from one month to three months. This is to make sure that those customers who do not claim Council Tax Support at the time they first need help – particularly those claiming Universal Credit Full Service - are able to receive more help, if they are entitled to it.

Council Tax Support claims are usually paid from the date that they are made. However, if the claimant can show good cause for not claiming promptly when they first needed help, we can backdate their claim to an earlier date.

## **Timeline and Implications**

An exploratory discussion with the Major Precepting Authorities (MPAs) about the proposed change to the CTS Scheme took place on 23 July 2018. They will also be invited to take part in the public consultation.

The public consultation will last for four weeks beginning on 3 September 2018, closing on 1 October 2018.

This project will require the commitment and support of the Revenues, Benefits and Exchequer Services, Communications and Consultation, the DMC, Business Support and Customer Management.

Information about the context of the consultation and the draft Scheme is required, which should be presented as simply as possible.

Although a self-completion questionnaire will be utilised and promoted principally online, consideration must also be given to the more vulnerable consultees. Paper copies and an Easy Read version will be made available to those who need them.

There should be communication, to begin as the consultation opens and take place throughout the consultation, including information on the Council's website.

In communications, there should be a link to support and advice services for those seeking information about the potential impact of the change.

#### Who we need to consult with


The proposed change to Derby's Council Tax Support Scheme is potentially relevant to all residents paying Council Tax in Derby. Therefore, the consultation will be universal.

# **Equality Impact Assessment (EIA)**

An EIA will be undertaken and a draft should be posted on the Council's website as part of the consultation during the consultation period. This will enable the EIA to be revised and finalised following the consultation and used to inform the final decision making process.
