Scheme of Delegations

SUMMARY

- 1.1 Since the Scheme of Delegations was last approved, new legislation has been introduced granting powers relating to the work of the Housing Standards team.
- 1.2 This report seeks approval for this legislation to be added to the Scheme of Delegations.

RECOMMENDATION

- 2.1 To note the proposals that powers under the following legislation be included in the Scheme of Delegations under the Director of Communities, Environment and Regulatory Services:
 - The Energy Efficiency (Private Rented Property) (England and Wales)
 Regulations 2015 made under the Energy Act 2011
 - Part 2 of the Housing and Planning Act 2016
- 2.2 To approve the amended Scheme of Delegations, capturing the changes referred to in recommendation 2.1, as detailed in Appendix 2.

REASONS FOR RECOMMENDATION

3.1 To ensure officers are appropriately empowered to undertake enforcement activity.

SUPPORTING INFORMATION

Energy Efficiency (Private Rented Property) (England and Wales) Regulations 2015

4.1 These regulations have been made under the Energy Act 2011, which is already included in the Acts under which the Director of Communities, Environment and Regulatory Services has power to act.

4.2	The regulations will specifically grant authority to take actions against landlords who let properties which are substandard in terms of energy rating. The power is not likely to come into force until 2018 but it is good practice to ensure the necessary approvals are in place at an early stage.

Part 2 of the Housing and Planning Act 2016

- 4.3 Powers under this Act will enable the council to take action against rogue landlords or those who serially contravene requirements in terms of housing conditions.
- 4.4 The power will enable officers to instigate proceedings against such individuals so that they can be prevented from acting as a landlord where it can be shown that they are not suitable due to serial contravention of regulations or criminal activity.

OTHER OPTIONS CONSIDERED

5.1 None. While the legislation permits councils to take enforcement activity, it is necessary for officers to be delegated the necessary authority in order for any enforcement activity they undertake to be protected against the risk of challenge.
