#### **SUSPENSION NOTICES**

Since 25 April 2012, the Authority has been able to serve a suspension notice on those who hold a licence under the Licensing Act 2003, who have not paid their annual fees.

25 suspension notices were issued during the period. The total outstanding was  $\pounds$ 3,450. 21 paid realising  $\pounds$ 2,950. Of the remaining 4, 2 licences were surrendered following the issue of the suspension notice, 2 suspensions remain in place, but are not currently trading.

#### INSPECTIONS

7 licensing inspections have been conducted during this period.
