## 06/07 Performance Eye

### a) Overview

The Commission considered a report from the Corporate Director of Corporate and Adult Services providing an overview of Performance Eye and details of a training event on 25 June 2007. Alison Eldam, Change Management and Performance Team, attended the meeting to answer questions on Performance Eye and gave a demonstration on how the system worked.

Councillor Bayliss suggested that Performance Eye would be more beneficial if e-mails could be automatically sent to Commission members if an indicator changed.

Alison responded that the system did have this functionality so emails could be generated for this Commission's indicators that went up or down. Alison added that currently co-opted members were unable to access the Performance Eye system at home. This was being looked at to enable co-opted members and partner agencies to have access.

- b) Quarter 4 Data 2006/7 including Annual Indicators

The Commission considered a report from the Corporate Director of Corporate and Adult Services providing quarter four 2006/7 performance data and associated commentaries. Additionally, an Issues and Comments paper on the Annual Indicators had been prepared by the co-ordination officer at the request of the Chair. There was a dialogue between members and Andrew Flack, Corporate Director for Children and Young People, about various Annual Indicators, including bullying, Key Stage 1 and 2 performance, teenage conceptions and the numbers on the Child Protection Register

compared to other councils. Under the Quarterly Indicators the shortage of suitable housing for 16 to 19 year olds was referred to.

The Commission received a presentation from Ifti Majid and Ian Murphy from Derbyshire Mental Health NHS Trust regarding the 26 week delay in the provision of an initial assessment and the measures they have put in place to reduce this waiting time, as requested by the Commission at its meeting on 13 March 2007.

Some of the issues that had resulted in the delay were: Recruitment Qualifications required for posts Thresholds Contingencies Case load management

Ifti and Ian explained to the Commission how these issues were or would be resolved and that they had structures and processes in place to address them and committed to being back on track by September 2007.

Resolved to receive an update from the Derbyshire Mental Health Trust in September 2007.

07/07 Overview and Scrutiny Commissions – Work Planning and Resources 2007/8

The Commission considered a report from the Corporate Director of Corporate and Adult Services on work planning and available resources to complete any work carried out. The report mentioned the need to consider pressures on the Department because of the need to prepare for external inspections in the autumn. At the request of the Chair, members had already been invited to suggest items for the work plan. The report proposed a means of finalising a work programme for the first part of the municipal year without having to wait until the next meeting in September.
