# Joined Up Care Derbyshire Update - development of the Derbyshire Integrated Care System (ICS)

# Purpose

1.1 This report provides an update from Joined Up Care Derbyshire (JUCD).

3.1 To ensure that the Health and Wellbeing Board is informed of, and engaged with, JUCD, ensuring alignment and joint effort as necessary on shared priorities.

# **Supporting information**

- 4.1 JUCD continues its progress in the development of Derbyshire's Integrated Care System (ICS).
- 4.2 The new statutory arrangements for integrated care systems (ICSs) will become effective from July 2022. Each ICS will comprise an:
  - Integrated Care Partnership (ICP): the broad alliance of organisations and representatives concerned with improving the care, health and wellbeing of the population, jointly convened by local authorities and the NHS.
  - Integrated Care Board (ICB) bringing the NHS together locally to improve population health and care.
- 4.4 The Derby and Derbyshire Integrated Care Partnership is a broad alliance of organisations and representatives concerned with improving the care, health and wellbeing of the population, jointly convened by local authorities and the NHS as equal partners in order to facilitate joint action to improve health and care outcomes and experiences, influence the wider determinants of health, and plan and deliver improved integrated health and care.

Within Derby and Derbyshire, it has been agreed that the Shadow Derby and Derbyshire Integrated Care Partnership (ICP) should be developed in two phases:

• Phase 1: January 2022 to September 2022

• Phase 2: September 2022 onwards.

Phase 1 will continue with the emphasis of the Shadow Derby and Derbyshire ICP being principally related to Health (including the NHS), Public Health and Social Care. The Shadow Derby and Derbyshire ICP will use this time to evaluate and agree the phase 2 role of the Derby and Derbyshire ICP i.e., what is the role of the Derby and Derbyshire ICP i.e., what is the role of the Derby and Derbyshire ICP and its relationship with the Health and Well Being Boards going forward, with particular reference to the wider determinants of health.

- 4.5 The Integrated Care Board is the statutory NHS body that will replace the CCG and inherit a range of new functions that will be delegated from NHS England. The ICB will receive the NHS financial allocation for Derby and Derbyshire and will have the important role of allocating it out across services to ensure the best outcomes are achieved.
