## 16/18      Apologies

Apologies were received from Councillors Graves and Wood and Melvin Harris, Ann Jackman, Anita Matthews, Phil Royle and Philip Webb.

## 17/18      Late Items Introduced by the Chair

## 18/18      Declarations of Interest

There were no declarations of interest.

## 19/18      Minutes of the Meeting Held on 26 June 2018 and Matters Arising

The minutes of the meeting held on 2018 were agreed as a correct record, subject to the following amendment.

That at 15/18 it was agreed that Eve Sacker would circulate information on the Jewish Living Experience exhibition to Members and provide an update at the following meeting.

## 20/18      Amendments to the Standing Advisory Council on Religious Education Constitution

Members received a report of the Strategic Director of Corporate Resources on Amendments to the Standing Advisory Council on Religious Education Constitution. The report was presented by the Democratic Services Officer.

It was reported that an amendment was required to paragraph 7 of the constitution to reflect the change in the number of representatives in Group C.

Members noted that the National Union of Teachers and the Association of Teachers and Lecturers were merging in the near future to become the National Education Union (NEU) therefore two representatives would be needed from the NEU to keep the representations correct.

Members agreed that at paragraph 7, Secondary Heads Association should be updated to Association of School and College Leaders.

Members noted that the constitution stated that there should be 5 representatives in Group D (representatives of Derby City Council) but that only 4 had been appointed at the Annual Meeting of Council in May 2018. Democratic Services Officer to investigate.

**Resolved to agree the draft Standing Advisory Council on Religious Education constitution, subject to the amendment as outline at the meeting.**

## **21/18      School of Sanctuary Presentation by the Head of Crich Junior School**

Cheryl Julian – Head of Crich Junior School gave a presentation on the work of the school as a School of Sanctuary.

It was reported that a School of Sanctuary was a school that was committed to being a safe and welcoming place for all, particularly asylum seekers and refugees. It was also reported that a School of Sanctuary was a school that helped its students, staff and wider community understand what it meant to be seeking sanctuary and to extend a welcome to everyone as equal, valued members of the school community. Members noted that being a place of inclusion was central to being a school of sanctuary.

It was reported that the City of Sanctuary had originally invited Crich Junior School to become a School of Sanctuary.

Members noted that a curriculum had been developed that worked for the school and that it changed each year. Cheryl stated that studying different faiths was central to this.

Members were informed about a range of activities that the school was involved in, such as:

- Family breakfasts
- Food banks for a refugee centre
- Activity days
- Collection boxes
- Birthday parties for teachers and TAs
- Annual camping event at Matlock Rugby Club
- Football with asylum seekers
- Growing and cooking project.

SACRE wish it to be noted that it commended the work of the school.

## **22/18      Derby Safeguarding Children Board - Update**

Naomi Feldman, DSCB Policy and Development Officer (Training), reported that the Arboretum Park Café had opened to support children, young people and families. It was also reported that holding meetings at the cafe was a very positive experience and that the resource was a relaxed and comfortable space to hold meetings and events. Members noted that there was crowd funding taking place to secure the future of the café. Members also noted that ESOL classes were held in the café every Monday - Thursday.

It was reported that a date had been set for safeguarding training at the Gurdwara Guru Arjan for 17 December 11.00am - 1.00pm and that Sam Mitchell and Naomi Feldman would deliver this course. It was also reported that Sam would also be looking for a date from Singh Saba Gurdwara to deliver safeguarding training.

Members noted that in 2018, over 70 teachers and volunteers from mosques and madrassahs had attended safeguarding training organised by DSCB and the Open Centre. Members also noted that as training organised at the Madeley Centre had been poorly attended, other venues would be considered for a while.

Members received an update on teaching classes for children at the Jamia Mosque and the positive impact that reducing class sizes and shortening the length of the sessions had had.

It was reported that there would be some child protection training at the Polish Catholic Church in the near future as this was another venue where children receive regular teaching.

This led to a discussion around the purpose of SACRE and ways to raise its profile.

Eve Sacker provided an update on the Jewish Living Experience exhibition. Members displayed interest in the exhibition and noted that Eve would enquire with the Board of Deputies as to the cost.

The Lead Officer to the SACRE reported that there would be an opportunity to use the exhibition as part of the forthcoming Derby and Derbyshire SACRE development day. Members noted that it could be linked to the activities around the Holocaust Centre.

Peter Harvey reported that he was due to attend the Humanist UK Conference in November, as a SACRE representative.
