## OTHER ENFORCEMENT ACTIVITIES UNDERTAKEN

#### Gaming Machines in Takeaways

Raised as an issue by the Gambling Commission, whereby takeaway proprietors were being approached by machine suppliers to have a skills machine in their business. When inspected by the technical division of the Commission it was discovered some of the machines were a gaming machine within a skills machine case.

254 takeaways were sent a letter and questionnaire to establish if they had any machines. 213 questionnaires were returned. The remaining 41 were visited to ensure they complied with the legislation. Currently, all takeaways within the city are compliant.

#### Suspension Notices

Since 25 April 2012, the Authority has been able to serve a suspension notice on those who hold a licence under the Licensing Act 2003, who have not paid their annual fees. In the first quarter, 14 suspension notices have been served. This gives the licence holder 2 days to pay the money due, before the licence is formally suspended. All businesses served with a notice paid, generating approximately £2600.
