The Apprenticeship Programme Update

Supporting information

4.1 Apprenticeship Team Current Priorities

4.1.1 National Apprenticeship Week 6 – 12 February

The theme for this year was 'Skills for Life'. The week reflected on how apprenticeships can help individuals to develop the skills and knowledge required for a rewarding career and help businesses to develop a talented workforce that is equipped with skills for the future.

The Apprenticeship Team had a very busy week:

6 February – Attended an event at Buxton and Leek College (part of the University of Derby) celebrating apprentice employers.

7 February – Attended the Derby College Student Event at Joseph Wright College – Employer stands promoting apprenticeships.

8 February – Attended the Schools and Colleges Careers Event at University of Derby, Kedleston Road Campus – Employer stands promoting apprenticeships.

Social Media – We worked with the Communications and Marketing Team, putting together case studies of current and past apprenticeships promoting the benefits of apprenticeships within Derby City Council posting them on our social media platforms throughout the week.

School Competition – On Monday 6 February we emailed all 24 secondary schools across the city launching our competition, asking students to produce an advert promoting apprenticeships in the city. Two winners were awarded the exciting opportunity to join our Communications and Marketing Team for a day to bring their advert to life and have it displayed on the screens across the city.

4.1.2 **Promoting Our Apprenticeship Opportunities**

- **11 January** Attended the Lees Brook Academy Parents evening promoting apprenticeships to students and parents.
- **6 & 7 March** Attended the 'Build Your Career' event at the University of Derby aimed at school students.
- **21 March** We attended the 'Derby Jobs Café' held in the Better Together Café specifically for people with additional needs.

4.1.3 **Partnership Working**

- Continuing to participate in the corporate recruitment and retention group, collaboratively working across all service areas to develop a strategic approach and priorities.
- Work is ongoing with the Care Leavers EET Development Board, supporting the positive destination strategy.
- Working with the 'Open Doors Forum' to promote apprenticeships opportunities to Black African Caribbean people of Derby.
- Participating in the Derbyshire Academy Bringing together representatives across Health, Community, Primary and Social Services to support the 'JoinedUpCareers' and Integrated Care initiatives.
- Continuing to partnership with the D2N2 Public Sector compact Group and the East Midlands Apprenticeship Ambassador network.

4.1.4 Workforce Development

Leadership and Management Programme

In February we had four more colleagues start in the Leadership and Management programmes.

Finance

The Apprenticeship Team are actively working with the Finance Team to support them with their development needs. Recent colleague starts include:

- 4 on level 7 Accountancy Professional
- 1 on Level 4 Professional Accounting Technician
- 2 on Level 3 Assistant Accountant

Social Care

We are continuing to work closely with the Children's Team, to support them to upskill their Residential Team enabling them to achieve the mandatory qualifications through apprenticeship programmes. We currently have 19 colleagues on a rolling programme and now have processes in place to enrol new starters once they have completed their probation period. We are also supporting to upskill colleagues in the teams with their maths and English functional skills to enable them to start on the apprenticeship programmes.

Three colleagues started on the Social Worker apprenticeship in January, two from Children's Services and one from Adult's Services. Taking the total number of colleagues on programme currently to 14, over four cohorts.

4.1.5 Levy Transfer

Under the currently Apprenticeship Levy funding rules, organisations are allowed to transfer up to 25% of their unspent levy to external employers to fund their apprenticeship programmes.

The Apprenticeship Team are working in collaboration with the Economic Regeneration Team to promote this opportunity.

We stipulate that the employer must either trade within the City or provide services to people who live within the city.

We are currently transferring Levy to seven employers in the city. We have recently pledged Levy to a further four employers which will support another 15 individuals on to apprenticeship programmes.

4.2 Apprenticeship Widening Participation Data

Periodically the Department for Education provide our widening participation data. The stats are based on all our apprentice starts, both new recruits and existing colleagues.

Below are the two most recent data sets:

Starts between April 2022 – August 2022:

- Registered disability including learning difficulties 14.8%
- 16–24-year-olds 37.7%
- Disadvantaged backgrounds 28.6%
- BAME 18.7%

Starts between August 2022 – December 2022:

- Registered disability including learning difficulties 16.1%
- 16-24-year-olds 34.4%
- Disadvantaged backgrounds 25%
- BAME 21.9%

The data supports the Council's overarching equality, diversity, and inclusion strategy.

4.3 Levy Payments

As of 28 March 2023, the Council has transferred a total of £4,321,994 into the Education and Skills Funding Agency (ESFA) Apprenticeship Levy Digital Account since the start of the Levy in April 2017.

To date the Council has drawn down £2,263,545 for internal apprenticeship training programmes and transferred £122,708 of our Levy Fund to external employers.

Between April 2022 and March 2023, £124,960 of the Councils Levy Fund has expired and has been returned to the government.

The total amount of Levy drawn down between May 2017 to March 2023 is $\pounds 2,924,448$.

The Financial report is included at Appendix 1.

Public/stakeholder engagement

5.1 Council departments, external training providers and local businesses.

Other options

6.1 Do nothing. This is not considered to be a viable option, the main reason being the Council wants to maximise the Levy spend and increase opportunities for colleagues and local people.

Financial and value for money issues

7.1 The Council continues to make contributions to the Levy monthly. Some of the funding is being used to pay for apprentice programmes every month please see Appendix 1 for the data. The Council is currently transferring funds seven external employers in the city. The Council has a rolling 24 months to use the funds and is experiencing the expiration of funds.

Legal implications

8.1 We are continuing to work with Legal and Procurement Services to ensure we are meeting our legal obligations with the Levy and procurement rules. The Government have put legislation in place; 'The Public Sector Apprenticeship Targets Regulations 2017'. Public sector bodies in scope of the target must submit annual returns appropriately demonstrating that they have had regard to achieving the 2.3% target. The Government have not put any penalties in place for not meeting the target, the onus is on having regard for it.

Climate implications

9.1 None arising from this report.

Socio-Economic implications

10.1 Apprenticeships provide opportunities for those from disadvantaged backgrounds to access new skills and careers (as monitored through the widening participation data).

Other significant implications

11.1 Equality implications are monitored as part of the widening participation data.
