Resolved to refuse the application on the grounds that the Committee considered the development was over intensive and out of keeping with the surrounding area. It was felt that there was insufficient car parking and visitor spaces. The Committee also felt that there were issues regarding safety when accessing the site.

It was agreed that Councillor Wynn would represent the Committee if an appeal against the decision was made.

4. DER/11/06/01841 Demolition of dwelling house and erection of residential care home. Site of 59 Blagreaves Lane, Littleover.

Mr Plumb and Councillor Marshall in objection to the application and Mr Wood for and on behalf of the applicant attended and addressed the Committee.

Resolved to refuse the application on the grounds that the development's physical dominance on the surrounding area would have a detrimental effect on the amenities of the surrounding area and the proposal represents over-development of the site.
