Patient-led NHS

As you may have seen in the local press, the Department of Health are looking for a reorganisation of PCTs as part of creating a patient-led NHS. This will mean a greater focus on commissioning services – that is assessing need and buying services from others – rather than providing services directly. There is also an expectation that there will be fewer, larger PCTs in future. Following discussion with all PCTs locally the options for this in Derbyshire were identified as:

- a single Derbyshire wide organisation, or
- separate city and county PCTs.

The Trent Strategic Health Authority (SHA) considered the final proposals alongside the plans from Nottinghamshire and Lincolnshire at their public Board meeting on 20 September. Following this meeting the SHA prepared their submissions to the Department of Health and recommended the two options for Derbyshire to be considered for public consultation. At present, the SHA is recommending a single commissioning body for the whole of the county as a preferred option.

We are now awaiting feedback from the Department of Health, which will be followed by a public consultation on the proposed developments.

Normanton GP practice

Dr J Paul will be retiring from his practice in the next few months. The PCTs are advertising both locally and nationally to ensure medical service provision for the practice population.

In the meantime a team of GP locums and additional sessions from our nurse practitioner team will ensure services are maintained for the patients registered with Dr Paul. These arrangements will continue until a final solution is determined.
