## Derby Older People's Plan

### SUMMARY

- 1.1 Derby Older People's Strategic Planning Partnership, DOPSPP, have now completed work on the first Older People's Plan for the city. This document has been widely consulted on over the summer through engagement mechanisms in the city, and has been developed as result of feedback from local people and partner agencies.
- 1.2 This document details our corporate and partnership approach to promoting positive outcomes for older people. It will thus be 'owned' by Derby City Partnership and renewed and refreshed through DOPSPP, drawing on on-going engagement with older people's groups and forums.
- 1.3 The plan will now be published and copies will be disseminated across key community centres and services across the city.
