# The Pledge

# SUMMARY

1.1 The Pledge is a promise made by Derby City Council to all Derby City children in care and leaving care. The Pledge is part of Derby's commitment to give children in care and leaving care the best opportunities they can have in life. All adults who work for and with the Council will make a commitment to work to the Pledge at all times.

The Pledge was originally conceived by the Derby City Children in Care Council throughout 2012

- 1.2 From June 15 August 15, The Children in Care Council have led work to update and develop a new Pledge. Looked after children have been asked to highlight their top ten priorities, which have formed the new Pledge.
- 1.3 The updated Pledge will be launched at a special Corporate Parenting Committee and implemented in 2016. Derby City Council and its members are Corporate Parents for children in care. It is expected that they embrace, support and implement the Pledge throughout their duties and service provisions.

# RECOMMENDATION

- 2.1 To receive the new Pledge.
- 2.2 To commit to implementing the Pledge across the council and corporate parenting partners.

# **REASONS FOR RECOMMENDATION**

- 3.1 There is an expectation for all local authorities to work with children and young people to develop a 'Pledge' for the children in their care. The pledge is a statement about the support and services children in care can expect to receive
- 3.2 Care Matters (2006) identified underpinning principles that Local Authorities must adhere to in complying with the basic statutory duties relating to Looked After

#### **Classification: OFFICIAL**

Children. It places a responsibility on Local Authorities to ensure children in care have been consulted and involved in developing the pledge and the regular review of the 'Pledge'

As corporate parents the council members and it officers have a duty to ensure the implementation of the Pledge. This should include consideration about services and functions of each department and how this can support the provisions within the Pledge.
