## Inspections of Children and Young People's and Adult Services

#### **SUMMARY**

- 1.1 Derby City Council's services for both children and young people and adults, including commissioned services and providers, are subject to regular external scrutiny by various inspectorates including; Ofsted, CQC and HMI Probation.
- 1.2 Preparing for an inspection is essential to achieving a successful outcome as it promotes internal self-awareness and allows corrective action to be taken as and when it is required to deliver improvements in both the quality of services and outcomes.
- 1.3 Although inspectorates review and challenge the Local Authority, as the lead agency in many inspection frameworks, the role of partners in supporting the services delivered and achieving positive outcomes is also evaluated (Often through an assessment of 'Leadership, Management and Governance').
- 1.4 It should however be noted that the profile of the local area as a whole, as evaluated through inspections, is in fact growing. There are two children's services inspection frameworks due to be launched early this year that will evaluate the local area's response to need in targeted areas rather than just that of the Local Authority (please refer to the table under paragraph 5.2)
- 1.5 The purpose of this report is to present members of the Health and Wellbeing Board with an update on the current inspection frameworks within both children and young people's and adult services. This is intended to support an increase in Board Member's knowledge and awareness of inspections frameworks. It should also prompt a local assessment of any risks for the Health and Wellbeing Board and the Board may want to commission further work linked to current services that it oversees and outcomes for key customer groups within priority areas, linked to the inspection frameworks.

#### **RECOMMENDATIONS**

- 2.1 To note the current inspections frameworks, outcomes from recent inspections and areas likely to be inspected in 2016.
- 2.2 To consider areas of risk related to the priorities of the Health and Wellbeing Board and what further action may be needed, with the service leads, to support improvements.

#### **REASON FOR RECOMMENDATIONS**

3.1 All inspections focus on outcomes for services users and the contribution of <u>all</u> agencies that support vulnerable children, young people and adults across the city.

## 4 Children and Young People's Services

- 4.1 Children and young people services is a highly regulated area comprising largely of
  - statutory services all of which are subject to the following external inspections by either; Ofsted, CQC or HMI Probation.
- 4.2 Overall, the number of frameworks has grown over the last three years with a number of new frameworks to be finalised in 2016...

4.3 Based on the frameworks available there are three core inspections that carry a high risk for the Health and Wellbeing Board (all of which may be inspected in 2016)...

- Inspection of services for children in need of help and protection, children looked after and care leavers.
- Inspection of services for special educational needs and disabilities.
- Integrated inspections of services for children in need of help and protection, children looked after and care leavers and joint inspections of the Local Safeguarding Children Board.
- 4.4 Full details of the inspection frameworks presented in paragraph 4.2 is available from the Performance and Intelligence Team or alternatively through Ofsted's / CQC's website.

#### 5 Adult Services Inspections

5.1 Compliance with essential standards of quality and care based on the Health and Social Care Act is an important requirement for all residential and nursing care homes in England and Wales. Individual locations and providers are registered under the Act and inspected according to CQC's inspection programme.

#### **Care Homes**

- 5.2 At the end of December 2015 74% of care homes within the city were fully compliant on all required inspection standards, which is above the national CQC benchmark of 65%.
- 5.3 The full compliance measure is quite a high bar for performance because at any given time all care homes need to be compliant with all inspected standards. This penalises those homes that have CQC improvement actions identified on some inspected standards and are subsequently compliant in those standards at a later date. A home could be compliant in 4 out of 5 inspected standards but would not be considered fully compliant.
- 5.4 To overcome this, an alternative way of looking at compliance is to take into account all inspected standards that care homes are compliant with. The overall compliance picture is more positive with 92.5% compliance on all inspected standards in all homes on the old system of inspection.

#### **Home Care Agencies**

5.5 Home care agencies have performed well on the old inspections regime with a rating at the end of December 2015 of 85.7% with 36 out of 42 agencies fully compliant with all standards.

## 6 Sector Led Improvement (Peer Challenge)

- 6.1 It should be noted that alongside the many mandatory inspection frameworks both adult and children's services are evaluated against that the services also contribute to the regional peer assessment process.
- 6.2 Through the regional programme all authorities receive an assessment on an identified key line of enquiry of their choice within 2 3 year period. Both adults and children's are scheduled to have an assessment in summer 2016 (the key lines of enquiry are yet to be confirmed).
- 6.3 It should also be noted that Derby City Council will be hosting a corporate peer review in spring / summer 2016.
