"The effect of planning guidance PPG3 later amended by PPS3 has been to designate domestic gardens as brownfield sites and has led to a large increase of planning applications from developers keen to buy up houses sitting on large plots in established suburbs for demolition and redevelopment with much higher density housing in its place.

Local authorities have little freedom to resist such applications and if the situation is left unchecked this planning freedom for developers will significantly alter and spoil well established residential suburbs to the detriment of residents who live in them. Whilst Council acknowledges the need for brownfield sites to be developed in preference to Greenfield sites it is clearly an anomaly that domestic gardens should fall into the brownfield site category and cannot be what the legislation intended.

Council therefore resolves to write to Government asking for more structured guidance on this issue, the removal of domestic gardens from the brownfield category and the ability to resist such applications where it is clear that there is a quality of life and loss of amenity consequence to giving such planning consents.

Government are also asked to consider how to strengthen the role of local ward members to put forward objections on behalf of their constituents to resist such inappropriate developments."

(2) Councillor Smalley to move, Councillor Marshall to second:

"Council congratulates Derby County Football Club on its promotion to the Premier League and wishes it every success as it begins the new season.

Council acknowledges the considerable opportunities that will result as many more visitors come to the City and the economic spin off that this will have for the local economy is not to be underestimated.

The Council therefore resolves to work with the football club to make the most of these benefits whenever it can to maximise these opportunities." Councillor Smalley to move, Councillor Hickson to second:

(3) "Council notes the considerable public concern about unsuitable and disrespectful uses of the War Memorial in the Market Place.

# **Budget and Policy Framework**

# 238/06 Capital Programme

The Council Cabinet considered a report which stated that Council had approved the capital programme for the three years to 2009/10 on 1 March 2007. The report sought to deal with adjustments to the current year programme. In some cases these had the effect of changing the totals for 2007/8 onwards due to slippage etc.

The further changes now included:

- reprofiling of the Pupil Referral Unit expenditure into 2007/8
- reprofiling of the football foundation funding for Lees Brook Community Sports College and Derby Moor Community Sports College expenditure into 2007/8
- allocation of schools devolved capital and modernisation funding for a new boiler at Wren Park Primary School
- reprofiling of Mickleover Library expenditure into 2007/8
- addition of Cathedral Green
- reprofiling of expenditure for the Rosehill Housing Market Renewal into 2007/8
- reprofiling of the Assessment Centre expenditure into 2007/8
- additional service financed borrowing for Grounds Maintenance equipment
- addition of the job evaluation capitalisation direction funded from corporate unsupported borrowing

• reprofiling of the planned maintenance expenditure into 2007/8.

A full revision to the programme for 2006/7 and the 2007/8 to 2009/10 programme would be placed on the Council's intranet following approval of these changes. The report also reported on monitoring of the progress in implementing the 2006/7 capital programme to date and the forecast year end position. Of the 2006/7 programme, 15.06% were completed and 74.24% of schemes were on site. Elements of the programme that carried relatively high risks in terms of costs, funding or performance delivery had been identified specifically and reported on. Approval was sought for full scheme commencement for the New Normanton School under Financial Procedure Rules.

- 1. To approve a revised capital programme for 2006/7 as set out in this report, with the 2007/8 to 2009/10 programme having indicative status consistent with previous Council Cabinet decisions, other than where full scheme commencement approval had been given.

The report updated Cabinet on the work that had been carried out on the development of Springwood Leisure Centre to form a new gym and library together with revised financial implications since Council approval of the initial scheme on 13 September 2006 and was included in the approved 2007/08 capital programme. The proposed new scheme showed that 40 additional fitness stations could now be accommodated on the site making 65 in total, which was a reduction of 35 on the original estimate of 100 fitness stations. The approved scheme included in 07/08 capital programme had a total cost of £1.172m, of which £1m for the cost of the new gym, was to be funded from self-financing prudential borrowing paid for from anticipated additional membership fee income. The estimated capital cost of the proposed new scheme was £1.262m, made up of £1.09m for the gym and £172k for the library. In order to remove the financial affordability risk based on the ambitious new membership targets included in the original scheme, it was prudent for the funding of the new scheme to be met from overall slippage within the approved capital programme. As it was anticipated that new membership fees would increase gradually over time at the rate of 8 new members a month which would require additional employees and running costs for the new gym, there was a projected revenue budget deficit of £72k in 2008/09, £53k in 2009/10, £33k in 2010/11 and reducing to £2k in 2011/12. This amounted to £160k over the four year period and would be met from within Environmental Services revenue budgets. An additional £57k for ongoing running costs for the library from 2008/09 going forward would be funded through a corporate allocation and would be identified as a pressure in the 2008/11 budget strategy report scheduled for Cabinet on 31 July 2007.

# **Options Considered**

- 1. Do nothing: this would prevent the development and improvement of the centre.
- 2. Library only: this would not be cost effective and could not be substantiated in terms of capital and running costs.

# Decision

To recommend Council to approve:

- 1. the amendment to the 2007/08 capital programme for the Springwood Leisure Centre and Library at a revised cost of £1.262m to be funded from slippage within the overall approved capital programme.
- 2. the underwriting of the annual running cost deficit of the gym for the first four years amounting to £160k in total from within Environmental Services revenue budgets.
- 3. £57k corporate budget allocation for the Library running costs from 2008/9.
- 4. the commencement of the capital scheme as soon as possible.

# FROM AREAS TO NEIGHBOURHOODS

## SUPPORTING INFORMATION

- 1.1 In December 2001, the Council introduced new constitutional arrangements including five Area Panels based on ward boundaries. The aim was to improve service delivery by providing an opportunity to discuss local issues with partners and local residents. Area Panels have met five or six times a year since then and have been the subject of an annual review looking at performance and processes.
- 1.2 In January 2006 the Council and key partners agreed to introduce more localised neighbourhood management arrangements in the "Priority Neighbourhoods" and these are now operational in Austin, Normanton/Peartree, Stockbrook, Osmaston/Allenton and Sinfin, together with the arrangements operating in the Derwent New Road area.
- 1.3 In May 2006 Council approved the need for a further review of Area and Neighbourhood working arrangements with the specific purpose of delivering a more strategic partnership agenda.
- 1.4 The Area and Neighbourhood Project Board took responsibility for co-ordinating the review on behalf of Derby City Partnership. The scope of the review was widened to include an evaluation of the work of the existing neighbourhood working arrangements in the priority areas.
- 1.5 The review included, piloting and reviewing area planning partnerships, holding visioning sessions with representatives from the Council, Derby Homes, Derbyshire Police, Derwent Community Team, Primary Care Trust, Derby Community Safety Partnership in December 2006 and February 2007, conducting desk top research, arranging Members' seminars, holding an Open Space event with residents and partners and reports to Area Panels.
- 1.6 Alongside the Area Panel review, both Derby Homes and Derbyshire Police have been reviewing their engagement processes to ensure that proposals are both integrated and fit for purpose.
- 1.7 In October 2006, while this review was taking place, the Government issued a White Paper on local government called 'Strong and Prosperous Communities'. The White Paper promotes community and neighbourhood engagement and is built on the assumption that public services need to be made more personal and therefore community engagement at the neighbourhood level is paramount.

- 1.8 In the White Paper the Government recognises public services have improved, but to continue the improvement, Councils, their partners and local communities need more opportunities to shape their local services and communities. The White Paper put forward proposals to improve community involvement, partnership working and leadership as vital elements to create strong and prosperous communities.
- 1.9 The Area and Neighbourhood Board has now concluded the review and, having taken into account the outcomes from the review and the Government White Paper and the success of neighbourhood management arrangements in the Priority neighbourhoods, has proposed a new framework for neighbourhood working that transforms Area Panels into Neighbourhood Forums. The aim of their proposal is to embrace a partnership commitment while engaging local people so they can influence decision that affect their daily lives. There are five reasons for the proposal:
  - to promote and enhance the community leadership role of elected members
  - to respond to the experience and evidence from Government and local neighbourhood management examples
  - to improve community engagement at a local level
  - to provide priority setting and increased accountability at a local level
  - to shape a local identity where local problems are resolved with local solutions in partnership with communities and agencies.
- 1.10 The Area and Neighbourhood Board proposes to roll out Neighbourhood Forums across the city as follows:
- 1.10.1 Council Constituted Area Panels are replaced with partnership oriented Neighbourhood Forums.
- 1.10.2 The current neighbourhood arrangements in Normanton, Arboretum, Abbey, Sinfin and Derwent wards will continue.
- 1.10.3 In wards where Neighbourhood Forums do not currently exist, the basic building blocks within each ward will be:

a Neighbourhood Board, led by elected members, in partnership with other public agencies, resident representations and private sector organisations as considered appropriate

- a Neighbourhood Forum open to all residents and chaired by elected members
- a Neighbourhood Manager and additional support as appropriate for the area (see 1.9.6)

- 1.10.4 Given the diverse nature of communities each Neighbourhood Board will consider the most appropriate community engagement strategy, taking into account:
  - the make up and geography of local communities
  - the capacity of the Council and its partners to support and service the community engagement process
  - the statutory consultation arrangements of each agency
  - the need to balance objectives of bringing communities together (making them more cohesive, rather than reinforcing divisions) with accessibility and geographical spread
  - the wishes of the community.
- 1.10.5 Each Neighbourhood Board will consider and develop priorities, an action plan and a community engagement plan.
- 1.10.6 At an operational level, supporting Boards and Forums, three levels of neighbourhood management will be developed to reflect the intensity of interventions.
  - Standard neighbourhoods, green, where a lighter touch of neighbourhood coordination will be provided; Darley, Allestree, Oakwood, Chellaston, Blagreaves, Littleover, Mickleover wards.
  - Enhanced neighbourhoods, amber, with support from Derby Homes Local Managers taking on the role of Neighbourhood Managers, with limited additional staff support, in Alvaston, Boulton, Chaddesden, Mackworth and Spondon wards
  - Priority neighbourhoods, red, already in place, each with its own Neighbourhood Manager and team, in Normanton, Arboretum, Abbey and Sinfin wards, together with the current arrangements in Derwent Ward through New Deal. (The priority neighbourhoods in these wards are Austin, Normanton/ Peartree, Stockbrook, Osmaston/Allenton and Sinfin, along with Derwent).
- 1.11 In Area 1 (Derwent, Chaddesden, Oakwood and Spondon) a substantial start has been made on implementing integrated frontline services for children, young people and their families by the partner agencies in the City for Children and Young People. This aims to provide easier, swifter access to more effective joint services, in order to improve outcomes for the communities young people. The experience in Area 1 will inform the roll out of this model across the city and the link to specialist city-wide services. Current area boundaries provide the basis for this work, but it seems likely that ultimately, across the five areas, there will be three area structures within which there will be locality teams. Consultation with children, young people and their families, and involvement indecision-making are being integrated into the processes.
- 1.12 The proposal to transform Area Panels into Neighbourhood Forums will require further work on constitutional and financial implications including how to deal with Executive functions that are currently delegated to Area Panels, which are receiving and responding to area based petitions and allocating a delegated budget for local environmental and community purposes. There will also be a need to examine the best method of servicing the new Forums.

1.13 These issues will be the subject of a further report to the Council Cabinet and full Council in September 2007, following consultation with the Community Overview and Scrutiny Commission.



#### SUPPORTING INFORMATION

- 2.5 The School Admissions Forum provides a vehicle for admission authorities and other key interested parties to get together to discuss the effectiveness of local admission arrangements, seek agreements on how to deal with difficult admission issues and advise admission authorities on ways in which their arrangements could be improved.
- 2.6 The Forum meets at least twice per year and has been in operation for just over four years. These appointments are necessary as the term of office for members has recently come to an end.

2.7 Recently the Government has granted the Forum new powers to prepare and publish reports on matters connected with the admission of pupils of maintained schools and to request information from the Council, neighbouring LEAs and governing bodies of maintained schools to help them prepare these reports

## The Review of Polling Districts and Polling Places (Parliamentary Elections) Regulations 2006

#### RECOMMENDATION

- 1.1 To approve the publication of a notice to review polling districts and polling places on 23 July.
- 1.2 To authorise the Corporate Director Corporate and Adult Services to carry out the statutory review in accordance with the proposals set out in this report.

#### SUPPORTING INFORMATION

- 2.1 The Council has always had a duty under the provisions of the Representation of the People Act 1983 RPA to keep the designation of polling districts and places in its area under review.
- 2.2 Constitutionally decisions on any changes to the designations following such a review are delegated to the Corporate Director of Corporate and Adult Services. In practice I only exercise this delegation following consultation with the three group leaders, ward councillors in the areas affected and the relevant party agents.
- 2.3 The Electoral Administration Act 2006 the Act has made amendments to the RPA with particular reference to the timing of reviews and the way in which the reviews of polling districts and places are conducted. Section 16 of the Act provides that a first full review must be completed before the end of a period of one year starting with the date that Section 16 came into force and every four years thereafter. Section 16 came into force on 1 January 2007 so the review must be completed and a final scheme agreed by 31 December 2007.
- 2.4 The Act has inserted a Schedule A1 into the RPA which sets out how a review is to be conducted and the Council as the relevant authority must comply with the following requirements:
  - publish a notice of the holding of a review
  - consult the acting returning officer for every parliamentary constituency which is wholly or partly in its area
  - every acting returning officer must make representation to the authority
  - the representations must include information as to the location of polling stations, existing or proposed, within polling places, existing or proposed.
  - the representations must be published in such a manner as is prescribed

- representations must be sought from people it thinks to have expertise in relation to access to premises or facilities for people who have different forms of disability
- such persons must have an opportunity to make representation and to comment on the returning officers representations
- any elector in a constituency situated in whole or in part in the authority's areas may make representations
- representations may include proposals for alternative polling places
- on completion of the review the Council must give reasons for its decisions
- 2.5 The Act introduces a requirement that an acting Returning Officer must make representations to the Authority on its proposed scheme. As the review is to be based upon the existing parliamentary constituencies and their boundaries, this means that for City of Derby the acting returning officers for Derby North, Derby South and South Derbyshire Parliamentary Constituencies must be consulted.
- 2.6 To progress the review it is proposed that a Notice of the Review be published on 23 July with copies of the review document available on request and on the Council's website. As we have reviewed our polling places annually it is proposed that the scheme used in the May 2007 City Council elections be used in the review document.
- 2.7 Copies of the notice and supporting documentation will be sent to all Councillors, party agents and organisations represented at the diversity forums. It is proposed that the closing date for representations be 24 September. It is intended that all representations received will be published on the Council's website to allow interested parties to comment on them. Members of the Disability Diversity Forum have previously expressed an interest in being involved in the review.
- 2.8 It is then proposed that the representations of the two acting returning officers will be published on 8 October with a further three weeks given to allow interested parties to comment on them. It is the intention that the Council will approve the final scheme at the meeting scheduled to take place on 27 November 2007.
- 2.9 The timetable is summarised below:

2.10 The legislation requires that all polling places and districts must be reviewed again within the next four years. The Council may wish to make alterations to polling districts between reviews. In such cases the Electoral Registration Officer will now be required to publish a notice fourteen days before the publication of the revised version in a local newspaper, at the Council House and at some other conspicuous place in the City.

#### IMPLICATIONS

#### Financial

1.1 In the 2006/07 and 2007/08 budget settlement approximately £85,000 was provided by the Department for Constitutional Affairs, now the Ministry of Justice, specifically to cover some of the costs of implementing the requirements arising from the Act. In both years when setting the budget the Council has agreed to allocate this funding directly to the Electoral Services Budget. All the proposals within this report will be contained within this funding.

#### Legal

2.1 Section 16 of the Electoral Administration Act 2006 amended the Representation of the People Act 1983 to require that relevant authorities must carry out periodic reviews of polling places and polling districts. The practicalities of how the reviews must be conducted are set out in The Review of Polling Districts and Polling Places (Parliamentary Elections) Regulations 2006.

#### Personnel

- 3.1 The Electoral Services Team comprises three full-time equivalent posts. This was increased from two full-time equivalent posts in October 2006. Benchmarking shows that Derby is still under resourced compared with other similar sized authorities. A report considered by the Scrutiny Management Commission at a meeting on 25 June demonstrated that the volume and complexity of electoral services work has increased significantly over the last three years.
- 3.2 The staffing levels in Electoral Services are currently being reviewed but any changes cannot be made before this review commences. Because the review will be taking place at the same time as the Annual Canvas it is anticipated that additional temporary staff will need to be appointed.

## **Equalities impact**

4.1 One of the key reasons for the new legislation is to ensure that polling places are as accessible as possible. The Council's equality and diversity forums and the organisations represented at the forums will be consulted as part of the review.

#### **Corporate priorities**

5.1 By improving the services provided by electoral services the action plan contributes to the Councils priority of making residents proud of their neighbourhoods by attempting to increase participation in decision making and democratic processes.

## **Consultation Document**

#### Background

Section 16 of the Electoral Administration Act 2006 introduced a number of changes to the Representation of the People Act 1983 in respect of the way in which reviews of polling districts and polling places must be carried out.

One of the most significant requirements is that by 31 December 2007, every relevant authority must have undertaken and completed a review of all the polling districts and polling paces in its area. This consultation document has been produced as part of Derby's first review.

The legalisation requires that reviews are carried out based on Parliamentary Constituencies. For the Derby North and Derby South Parliamentary Constituencies, and the parts of the South Derbyshire Constituency which fall within the City boundaries, Derby City Council is the relevant authority. For those areas outside of the City which fall within the South Derbyshire Parliamentary Constituency, South Derbyshire District Council is the relevant authority. They will be carrying out their own separate review.

#### Definitions

#### a) Polling Districts

A polling district is a geographical sub-division of an electoral area, such as a parliamentary constituency or a ward.

As the relevant authority, the Council is responsible for designating polling districts, and must therefore seek to ensure that all electors in the parliamentary constituency have such reasonable facilities for voting as are practicable in the circumstances

#### b) Polling Places

There is no legal definition of what a polling place is. However in Derby a polling place is a geographical location in which a polling station is situated. Although it is usual to have one polling station in one polling place, there are situations where several polling stations are located in one polling place.

As the relevant authority, the Council is responsible for determining polling places, and must therefore make sure that the polling places are accessible to all electors and must take into account the accessibility needs of disabled people.

#### c) Polling Stations

A polling station is the actual area in which the process of voting takes place and must be located in the polling place designated for the particular polling district. The polling station may consist of a whole room or in certain circumstances a designated area within a room or building.

The Returning Officer for the particular election is responsible for providing a sufficient number of polling stations and allotting electors to those polling stations. As a consequence the determination of polling stations is outside the scope of this review. However polling stations must be located within the polling places designated by the Council, and these are within the scope of the review.

#### **The Review Process**

The timetable for the review is set out below:

Publication of notice and consultation document	23 July 2007
Closing date for representations	24 September 2007
Publication of representations from both Returning Officers	8 October 2007
Final date for comments on the representations from the Returning Officers	29 October 2007
Full Council approves final scheme	27 November 2007
2008 Electoral Register published in accordance with the new scheme	1 December 2007

The publication of this consultation document represents the first stage of the review. The existing schedule of polling districts and polling places is included in Appendix A. This appendix also provides a breakdown of the number of electors allocated to each polling district. In Appendix B we have provided a set of maps which illustrates where the boundaries of the polling districts are located. Copies of the maps and this document are available on the Council's website at www.derby.gov.uk/elections.

As part of this first stage you are invited to comment on the existing scheme, and if you feel it appropriate you may suggest changes to polling district boundaries or alternative proposals for polling places. It would help us if you could also give reasons for the changes you have suggested.

All representations will be published on the Council's website as soon as possible after receipt, even if you have already commented on the proposals; you may make further submissions in response to views and comments you see on the website.

Any representations you wish to make should be received by Monday 24 September.

#### What happens next?

On 8 October the views of both Returning Officers on both the scheme and any representations made will be published. You will then have until Monday 29 October to comment on their submissions. On 27 November the Council will consider all the issues raised and publish its final scheme, according to which the 2008 electoral register will be published on 1 December.
