Draft Scoping Report for the Review of Extra Care Housing

SUMMARY

- 1.1 At the last meeting the Board agreed to review the barriers and enablers to delivering Extra Care facilities in the city. This draft report outlines the key aims and objectives of the review and asks the Board to identify witnesses to give evidence and set a timetable for completion of the review.

RECOMMENDATION

- 2.1 To consider and adopt the scoping the report.

REASONS FOR RECOMMENDATION

- 3.1 The Boards should set tight parameters to conduct an effective review and achieves positive outcomes.

SUPPORTING INFORMATION

- 4.1 Derby's aging population continues to grow. It is expected that the number of people aged 85 and over will double between 2010 and 2025 to around 23000 people.
- 4.2 We currently have seven care homes with approximately 257 beds between them. It is expected that by the end of 2012 we will have 174 units of Extra Care housing in three separate complexes. This will further increase by 70 units by 2014.
- 4.3 It is proposed to undertake a detailed review of Extra Care which aims:
- To ensure that the development of Extra Care units and the packages of care combined, are viable and bring benefits to not only service users, but also the Council.
- 4.4 The Objectives of the review are:
- To understand the range and sources of service user type who may wish to

live in an Extra Care environment.

- To explore the level of care needs (i.e. low to critical) and the typical care packages and funding if any, offered to each type in an Extra Care environment.
- Examine the flow of demand and where that is anticipated to come from.
- Make comparisons against existing service user groups (i.e. from low to critical) and where/how they are currently accessing care provision if any. Furthermore do any clients in residential care qualify for Extra Care provision?
- To examine the development and demand of Extra Care i.e. is the demand there for current plans/do current plans meet demand ?
- What lessons can we learn from existing and past developments and the models of care delivered in Extra Care environments?
- To identify the level and types of residential care required in the city over the next 20 years
- To consider the barriers and enablers for delivering Extra Care housing
- To Identify potential witnesses to give evidence
- To establish a draft timetable for completion of the review
