Environment Commission Topic Review 2006/07: A Review of Public Art in Derby

RECOMMENDATION

1. That Scrutiny Management Commission approves the review of Public Art in Derby that the Environment Commission has selected as its workplan topic for 2006/07.

SUPPORTING INFORMATION

- 2.1 At its meeting on 31 July 2006, the Environment Commission agreed that as its workplan topic for 2006/07 it would conduct a review of Public Art in Derby.
- 2.2 The Commission decided that at a time when the city is undergoing significant development that this would be an appropriate time to consider public art. The Commission also received details of all the past and current Section 106 agreements which have secured public art, which is attached at appendix 2 of this report.
- 2.3 The review will start in September with the intention of completing it and reporting the findings to the Council Cabinet Member for Leisure and Direct Services before Christmas 2006.
- 2.4 At the time of writing this report the Commission had yet to draft its scoping report. This can be brought to a future meeting of Scrutiny Management if the Commission wishes.
