Report of the Chief Officer, Southern Derbyshire CCG

A Call to Action

SUMMARY

- 1.1 Because of the pressure facing the NHS, the current models of service delivery are likely to be unsustainable. NHS England has launched *A Call to Action*, which requires each Clinical Commissioning Group to engage with the public, Health and Wellbeing Boards and other stakeholders to explain the challenges ahead, and to then develop a 5 year Commissioning Plan.
- 1.2 The Integration Transformation Fund is a new arrangement announced in the Chancellors Autumn Statement that requires CCGs and Local Authorities to work together to develop integrated service provision. This work is supported by the transfer of 3% of existing NHS funding in to a pooled budget. Details of how the Fund will be used need to be included in the CCG's Commissioning Plan
- 1.3 Currently, a fund of £4.11m already transfers from the NHS locally to Derby City on an annual basis. The use of this funding has to be agreed through the Health and Wellbeing Board.

RECOMMENDATION

- 2.1 Note the action required by the CCG to develop a five year commissioning plan, as set out in *A Call to Action*
- 2.2 Consider its leadership role in the consultation process of A Call to Action
- 2.3 Agree the arrangements for developing proposals for the use of the integration Transformation Fund
- 2.4 Approve the transfer of funds between the CCG and the City Council for 2013/14 for the purposes specified in the Section 256 agreement

REASONS FOR RECOMMENDATION

- 3.1 The recommendations clarify the governance arrangements for taking forward *A Call to Action* and developing proposals for commitment of the Integration Transformation Fund
- 3.2 The recommendation with respect to the use of Section256 funding in 2013/14 will enable the transfer of funds from NHS England to Derby City
