- that there be much more design input into the scheme as they felt the aesthetics need to be looked at further. It was raised that the materials used need to be carefully considered

  – the importance of the brick and stone choice, the bond used in laying brickwork and their need to relate to their context.
- 2) to object to the current proposal's need to demolish two locally listed buildings in the north riverside area and questioned whether a third would also be affected. It was suggested that this area be re-examined and the possibility of water being directed across the area in underground tunnels or open storm culverts instead. It is emphatically hoped that the buildings in question can be retained.
