#### RECOMMENDATION

  - a) The actions it is proposed to take in response to the recommendations made by the Commission in the report on its review of the Council's Tree Management Policy.
  - b) The reasons for proposing those actions.

# SUPPORTING INFORMATION

## **Background**

- 2.1 The outcomes and recommendations of the Planning and Environment Commission's review of the Council's Tree Management Policy were reported to Council Cabinet at its meeting on 21 December 2004.
- 2.2 Having considered the Commission's report, Cabinet decided 'To welcome the report and request the Director of Commercial Services to provide a response by the end of March 2005 after the recommendations had been fully assessed'.

#### Issue(s)

- 2.3 No response was provided to the Planning and Environment Commission by the end of March 2005 but on 6 April 2005 the Chair of the Commission was sent the e-mail shown in Appendix 2 of this report.
- 2.4 The lack of a proper response to the report of its review of the Tree Management Policy was discussed by the Planning and Environment Commission at its meeting on 21 April 2005. Members were concerned that no response had been made to the Commission within the time period specified by Council Cabinet. Members were also concerned that they

had not been kept informed of any actions proposed by the Director of Commercial Services.

#### **Conclusions of the Commission**

2.5 The Commission resolved to ask Council Cabinet to provide a response to the report to the Commission's meeting on 2 June 2005.

It was my intention to have taken a report to Cabinet in March regarding a response to the O & S report on the Tree Management Policy. I wanted to give you an update.

As you will be aware from the budget settlement, resources have been allocated to implement an inspection programme of trees on highway verges and on parks near to car parks, footpaths, play areas and where there is reasonably heavy pedestrian usage. This work has commenced. We are in discussions with colleagues about the approach to be adopted on housing land.

My principal reason for not being able to have presented a report is regarding the ability to challenge the decision of an Arboricultural Officer not to undertake work to trees. The proposal to refer disputes to Area Panels is considered to be unworkable. This is due to several factors including the number of potential disputes, the pressure that could be exerted upon councillors, a consistency of approach across the city, the necessity to have site visits, the time available at Area Panels and the budget available for cosmetic work to trees. It was this issue that let to my request for Overview and Scrutiny to examine the Tree Management Policy. I am in the process of evaluating what, if any, options may be practically applied and when, this is complete, I will report to Cabinet.
