06/06 Application for a Variation of Club Premises
Certificate at the Polish Club and Catholic Centre

The Sub Committee considered a report from the Director of Environmental Services that detailed an application for a variation of club premises certificate at the Polish Club and Catholic Centre, 18 Kedleston Road, Derby, DE22 1GU.

The application was received on 3 May 2006 from Mrs Sudnik. Mrs Sudnik attended and addressed the Sub-Committee. Mrs Sudnik called Mrs McIntosh and Mrs Nowak as witnesses.

The variation applied for was additional hours for all activities excluding boxing or wrestling.

It was reported that three representations had been received from members of the public. Mr Branson, Mr Stringer, Mrs Hughes attended and addressed the Sub-Committee. Mr Branson called Mrs Tretton as a witness.

# The Sub-Committee resolved to grant the variation at the Polish Club in the following way:

To extend the hours for the provision of alcohol and regulated entertainment as follows:

### **Activity**

Plays, Exhibition of films, Indoor Sporting Events, Live Music, Recorded Music, Performances of dance, Anything of a similar description to live music, recorded music or performance of dance, Provision of facilities for dancing and anything of a similar description to provision of facilities for dancing,

#### **Hours**

Monday – Sunday 10.30am – 0.00am

Supply of alcohol

Monday – Sunday 10.30am – 0.00am

And the non standard hours detailed in the operating schedule attached to the application for variation, where they relate to the transmission for a televised world sporting event where a British or Polish team are taking part and any final match, which falls outside the above hours.

In order to promote the 4 Licensing Objectives, the following additional conditions were attached to the Club Premises Certificate:

#### CONDITIONS RELATING TO CRIME AND DISORDER

## 1. CCTV

- 1.1 You must maintain the existing CCTV system in good working order on the premises.
- 1.2 The system must be operated at all times when the premises are open.

#### CONDITIONS RELATING TO THE PREVENTION OF PUBLIC NUISANCE

2. You must display prominent, clear and legible notices at all exits and in the car park requesting customers to respect the needs of local residents,

- ensure that noise does not unreasonably disturb others and to leave the premises and the area quietly.
- 3. All external doors and windows must be kept closed, other than for access and egress, when activities involving amplified music or speech are taking place.
- 4. You must nominate a representative to monitor the noise from time to time at the boundary of your premises when activities involving amplified music or speech are taking place. If, as a result of such monitoring, it is considered that the noise levels are excessive, immediate action should be taken to take reasonable steps to reduce noise to an acceptable level.
- 5. You must continue to monitor customers leaving the premises to ensure they do not unreasonably disturb local residents and that they leave the premises quietly.

#### CONDITIONS RELATING TO THE PROTECTION OF CHILDREN FROM HARM

**6.** You must not allow children under 18 on the premises unless accompanied by an adult.
